# SUBVECTOR INFERENCE IN PI MODELS WITH MANY MOMENT INEQUALITIES 

By A. Belloni, F. Bugni and V. Chernozhukov

This paper considers inference for a function of a parameter vector in a partially identified model with many moment inequalities. This framework allows the number of moment conditions to grow with the sample size, possibly at exponential rates. Our main motivating application is subvector inference, i.e., inference on a single component of the partially identified parameter vector associated with a treatment effect or a policy variable of interest.

Our inference method compares a MinMax test statistic (minimum over parameters satisfying $H_{0}$ and maximum over moment inequalities) against critical values that are based on bootstrap approximations or analytical bounds. We show that this method controls asymptotic size uniformly over a large class of data generating processes despite the partially identified many moment inequality setting. The finite sample analysis allows us to obtain explicit rates of convergence on the size control. Our results are based on combining nonasymptotic approximations and new high-dimensional central limit theorems for the MinMax of the components of random matrices, which may be of independent interest. Unlike the previous literature on functional inference in partially identified models, our results do not rely on weak convergence results based on Donsker's class assumptions and, in fact, our test statistic may not even converge in distribution. Our bootstrap approximation requires the choice of a tuning parameter sequence that can avoid the excessive concentration of our test statistic. To this end, we propose an asymptotically valid data-driven method to select this tuning parameter sequence. This method generalizes the selection of tuning parameter sequences to problems outside the Donsker's class assumptions and may also be of independent interest. Our procedures based on self-normalized moderate deviation bounds are relatively more conservative but easier to implement.

1. Introduction. This paper contributes to the growing literature on inference in partially identified econometric models defined by a large number of moment inequalities. As discussed by Tamer [52], Canay and Shaikh

[^0][23], and Ho and Rosen [41], partially identified moment inequality models arise naturally in a large variety of economic problems and have been increasingly used in the empirical literature. As argued in Chernozhukov et al. [25], the number of moment inequalities implied by many econometric applications is frequently very large relative to the sample size. Examples of this include Bajari et al. [13], Ciliberto and Tamer [36], Pakes and Porter [46], Beresteanu et al. [17], Galichon and Henry [40], Chesher et al. [34], and Chesher and Rosen [33].

There is a substantial literature on inference of the entire parameter vector in a partially identified moment inequality model. An earlier strand of this literature considered partially identified models defined by a finite number of unconditional moment inequalities ${ }^{1}$ and conditional moment inequalities ${ }^{2}$. More recently, Chernozhukov et al. [25] study the problem of the entire parameter vector in partially identified models with many moment inequalities. According to this asymptotic framework, the number of moment inequalities is allowed to grow with the sample size, possibly at exponential rates. Furthermore, the moment inequalities in this framework are allowed to be unstructured, in the sense that no restrictions are imposed on their correlation structure. ${ }^{3}$ As Chernozhukov et al. [25] explain, the many moment inequalities framework substantially expands the scope of applications by allowing the number of unstructured moment inequalities to be much larger than the sample size.

The main contribution of this paper is to propose inference for a function of a parameter vector in a partially identified models with many moment inequalities. Our main motivating application is subvector inference, i.e., inference on a single component of the partially identified parameter vector that is associated with a treatment effect or a policy variable of interest. Our inference method is based on the MinMax test statistic, where the minimum is computed over the parameter values that satisfy the null hypothesis (i.e. profiling) and the maximum is computed over an index of the moment inequalities. We propose comparing the MinMax test statistic against critical

[^1]values that can be based on bootstrap approximations or analytical bounds. We show that the resulting inference method with either of these critical values controls asymptotic size uniformly over a large class of data generating processes.

There is a recent literature on the problem of inference for a function of a partially identified parameter in a moment inequality model. This literature focuses on moment inequality models with finitely many moment conditions, which can be restrictive in certain applications. We now summarize this literature. Andrews and Guggenberger [2] and Andrews and Soares [7] propose conducting projection-based inference, i.e., intersecting the confidence set for the entire parameter space with the subset of the parameter space that satisfies the null hypothesis. Bugni et al. [21] show that projection-based inference can result in power losses relative to profiling-based methods. Romano and Shaikh [49] consider profiling-based inference with critical values constructed using subsampling. In turn, Bugni et al. [21] and Kaido et al. [42] consider profiling-based methods with critical values constructed using the bootstrap. Gafarov [39] considers subvector inference in affine moment inequality models. As already mentioned, these references restrict attention to partially identified models with a finite number of moment conditions. This restriction becomes essential in proving the asymptotic validity of the proposed inference. For example, it implies that profiling-based test statistics, such as the MinMax statistic, converge in distribution to a function of a Gaussian process. In contrast, these statistics may not even converge in distribution in the many moment inequality setting considered in this paper.

More recently, Chernozhukov et al. [32] consider inference for subvector on partially identified conditional moment restriction models with a conditioning covariate of restricted dimension. This restriction imposes enough structure on the problem to allow them to use Koltichinskii's Hungarian couplings and approximate the relevant empirical processes by the corresponding Gaussian processes. By contrast, our approach is designed to be valid in a framework with many moment inequalities that does not impose the structure produced by having a small number continuous conditional moment inequalities, enabling a much broader set of applications.

Our inference method compares the MinMax test statistic with critical values based on bootstrap approximations or analytical bounds. Both methods have their relative merits. The first set of main results pertains to bootstrap approximations that exploit correlation structures to increase power. These procedures were inspired by the ideas in Bugni et al. [21] which considered a finite number of inequalities but for a broader class of test statistics. By considering many moment inequalities to cover a wide range of appli-
cations, we develop new theoretical arguments to establish the validity of our bootstrap procedures. In particular, non-asymptotic bounds and new high-dimensional central limit theorems for the MinMax statistics were developed. ${ }^{4}$ Our second set of main results is on the construction of analytical bounds based on self-normalized moderate deviation theory which are computationally easier but do not exploit the underlying correlation structure. We build upon arguments in Chernozhukov et al. [25] which considered the vector inference problem but also allowed for many moment inequalities.

As it is usual in this literature, our bootstrap approximation requires a threshold sequence $\left(\kappa_{n}\right)_{n=1}^{\infty}$ that determines whether each moment inequality is considered to be sufficiently close to binding or not. In models with finitely many moment inequalities, the threshold sequence is required to satisfy $\kappa_{n} \rightarrow \infty$ and $\kappa_{n} / \sqrt{n} \rightarrow 0$. We show that the many moment inequality setting imposes additional requirements on the threshold sequence. In order to facilitate this choice for practitioners, we propose a data-driven method to select this threshold sequence in an asymptotically valid way.

In deriving our primary results, we also obtain several auxiliary findings that might be of independent interest. First, we derive a new non-asymptotic coupling result for the MinMax of an empirical process (see Theorem 10). A key ingredient to obtain such coupling is a novel use of a smooth approximation of the MinMax functional. Second, the data-driven procedure proposed to estimate the anti-concentration of the MinMax statistic seems to be widely applicable to other contexts, as it allows one to bypass the need to development of anti-concentration bounds that are only available to a limited class of statistics, such as the Max statistic. Both results are new and could be of independent interest beyond our contribution.

The paper is organized as follows. Section 2 formally describes the setting and problem. We provide an overview of some of our main results in Section 3 where we discuss insights and key issues. Section 4 derives our main theoretical results for different procedures. We discuss in detail the anticoncentration properties associated with the MinMax statistics in Section 5. Section 6 provides new coupling results for the MinMax of non-centered empirical processes and for the sum of independent random matrices which are of independent interest.
2. Setup and Test Statistics. Let $(S, \mathcal{S})$ be a measurable space, and let $\left(W_{i}\right)_{i=1}^{n}$ denote an i.i.d. sequence of random variables taking values on $(S, \mathcal{S})$ with common distribution $P \in \mathcal{P}$, and let $\theta \in \Theta \subseteq \mathbb{R}^{d_{\theta}}$ denote the

[^2]parameter of the model. The econometric model predicts that true parameter value, $\theta^{*} \in \Theta$, satisfies the following collection of $p_{I}$ moment inequalities and $p_{E}$ moment equalities:

If we let $m_{j}(W, \theta) \equiv m_{I, j}(W, \theta)$ for $j=1, \ldots, p_{I}$ and $m_{p_{I}+j}(W, \theta) \equiv$ $m_{E, j}(W, \theta)$ for $j=1, \ldots, p_{E}$, and $m_{p_{I}+p_{E}+j}(W, \theta) \equiv-m_{E, j}(W, \theta)$ for $j=$ $1, \ldots, p_{E}$, (2.1) can be equivalently re-expressed as moment inequality model with $p \equiv p_{I}+2 p_{E}$ moment inequalities:

We allow the econometric model to be partially identified, i.e., the moment inequalities in (2.2) do not necessarily restrict $\theta^{*}$ to a single value, but rather constrain it the identified set, given by:

\Theta_{I} \equiv\left\{\theta \in \Theta: \mathrm{E}\left[m_{j}(W, \theta)\right] \leq 0 \text { for } j \in[p]\right\} \tag{2.3}
\end{equation*}

We are implicitly allowing the distribution P of the data to change with the sample size. In particular, the dimensionality of $\Theta$, denoted by $d_{\theta}$, and the number of moment inequalities $p$ to depend on $n$. In particular, we are primarily interested in the case in which $p=p_{n} \rightarrow \infty$, but the subscripts are omitted to keep the notation simple. In particular, $p$ can be much larger than the sample size $n$.

Let $h: \Theta \rightarrow \mathbb{R}^{d_{h}}$ be a known function, let $h[\Theta]$ denote the image of $h$, and let $\bar{h} \in h[\Theta]$ be an arbitrary parameter value. Our goal is to conduct the following hypothesis test:

\end{equation*}

The main application of our test is the subvector inference problem, i.e., testing whether a subset of the partially identified parameter vector is equal to a particular value or not. For example, we could test whether, say, the $s^{\prime}$ th coordinate of $\theta^{*}, \theta_{s}^{*}$, is equal to a particular value $\bar{h} \in \mathbb{R}$ or not, i.e.,

H_{0}: \theta_{s}^{*}=\bar{h} \quad \text { vs. } \quad H_{1}: \theta_{s}^{*} \neq \bar{h} \tag{2.5}
\end{equation*}
$$

(2.5) is a particular example of (2.4) with $h(\theta)=\theta_{s}$.

To test (2.4), we propose the "MinMax" test statistic, defined as follows:

T_{n}(\bar{h}) \equiv \inf _{\theta \in \Theta(\bar{h})} \max _{j \in[p]} \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j}, \tag{2.6}
\end{equation*}

where $\Theta(\bar{h})$ is the "null set" associated to (2.4), given by:

\Theta(\bar{h}) \equiv h^{-1}[\{\bar{h}\}]=\{\theta \in \Theta: h(\theta)=\bar{h}\}
$$

and

$$
\bar{m}_{\theta, j} \equiv \frac{1}{n} \sum_{i=1}^{n} m_{j}\left(W_{i}, \theta\right), \quad \hat{\sigma}_{\theta, j}^{2} \equiv \frac{1}{n} \sum_{i=1}^{n}\left\{m_{j}\left(W_{i}, \theta\right)-\bar{m}_{\theta, j}\right\}^{2} .
$$

Finally, if $\hat{\sigma}_{\theta, j}=0$ in (2.6), we define $\bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j} \equiv \infty \times \operatorname{sign}\left(\bar{m}_{\theta, j}\right)$.
Given the test statistic in (2.6) and nominal size $\alpha \in(0,1)$, our goal is to present critical values $c_{n}(\bar{h}, \alpha)$ that can be associated with $T_{n}(\bar{h})$ to produce asymptotically valid inference for (2.4). Specifically, we propose to reject $H_{0}$ in (2.4) if and only if

By exploiting the duality between hypothesis tests and confidence sets, we construct a confidence set for $h\left(\theta^{*}\right)$ by collecting all parameter values $\bar{h}$ for which we do not reject, i.e.,

C_{n}(1-\alpha) \equiv\left\{\bar{h} \in h[\Theta]: T_{n}(\bar{h}) \leq c_{n}(\bar{h}, \alpha)\right\} . \tag{2.8}
\end{equation*}

Our formal results will have the following structure. Under $H_{0}$, we show that

\begin{equation*}
\mathrm{P}\left(T_{n}(\bar{h})>c_{n}(\bar{h}, \alpha)\right) \leq \alpha+C n^{-c} \tag{2.9}
\end{equation*}
$$

where $c$ and $C$ are constants that depend only on other constants of the problem (i.e. they do not depend on $\bar{h}, \mathrm{P}$, or $n$ ). As a corollary of this, the convergence in (2.9) occurs uniformly over a suitable class of probability distributions.

The main contribution of this paper is to propose methods to approximate the critical value $c_{n}(\bar{h}, \alpha)$ that satisfies (2.9) in the many inequalities setting. To this end, we develop an approximation to the asymptotic distribution of the MinMax test statistic $T_{n}(\bar{h})$ based on suitably constructed bootstrap procedures and based on self-normalized moderate deviation theory.

Remark 1 (Many Conditional moment inequalities). The analysis developed here can be applied to models defined by many conditional moment inequalities/equalities where the number of moment restrictions can be unbounded, see e.g. Chernozhukov et al. [26] and Andrews and Shi [5]. Formally, we have

where $\mathcal{I}$ is a set of indices for the moment inequalities and $\mathcal{E}$ for the moment equalities. As we show below, the results developed here are directly applicable to these models as well. We first reexpress the conditional moment conditions into equivalent unconditional ones via instrumental functions $g \in \mathcal{G}$, given by

\mathrm{E}\left[m_{\tau}(W, \theta) g(X)\right]=0, \quad \tau \in \mathcal{E}
\end{array}\right\}

3. Overview of Main Results. In this section we provide a simplified discussion of the issues and proposed methods to construct critical values that are asymptotically valid in the sense of (2.9). This section intends to motivate the key issues we face and more general results and other procedures are discussed in Section 4.

An important feature of the MinMax statistic (2.6) is that it is a functional of non-centered sums. Therefore it is convenient to highlight the centering and rewrite the MinMax statistic as

T_{n}(\bar{h})=\inf _{\theta \in \Theta(\bar{h})} \max _{j \in[p]}\left\{\hat{v}_{\theta, j}+\sqrt{n} \mathrm{E}\left[m_{j}(W, \theta)\right] / \hat{\sigma}_{\theta, j}\right\},
$$

where $\hat{v}_{\theta, j}$ is the centered empirical process indexed by $\theta \in \Theta$ and $j \in[p]$, i.e.,

$$
\hat{v}_{\theta, j} \equiv n^{-1 / 2} \sum_{i=1}^{n}\left\{m_{j}\left(W_{i}, \theta\right)-\mathrm{E}\left[m_{j}(W, \theta)\right]\right\} / \hat{\sigma}_{\theta, j} .
$$

There are two main insights in the derivation of critical values for the MinMax statistics. Under $H_{0}, T_{n}(\bar{h}) \leq \max _{j \in[p]} \sqrt{n} \bar{m}_{j}\left(\theta^{*}\right) / \hat{\sigma}_{\theta^{*}, j} \leq \max _{j \in[p]} \hat{\theta}_{\theta^{*}, j}$. However, also under $H_{0}, h\left(\theta^{*}\right)$ is known and yet the parameter vector $\theta^{*}$ may not be known. Therefore, in addition to considering which inequalities can be binding, it is important to consider which values of the parameter $\theta$ are candidates to be $\theta^{*}$ based on the moment inequalities and $h\left(\theta^{*}\right)=\bar{h}$. Note however that these two "selection" problems have very different consequences in the analysis of the size of the test. That is, overselecting inequalities leads to potentially conservative but valid asymptotic size control, while over selecting values of $\theta$, because of the minimum, can lead to a procedure that fails to control asymptotic size. In particular, using a critical value based on bootstrapping $\min _{\theta \in \Theta(\bar{h})} \max _{j \in[p]} \hat{v}_{\theta, j}$ will fail to control asymptotic size even if $p=2$ for simple data generating processes. ${ }^{5}$

[^3]We begin with a bootstrap-based procedure for the construction of a critical value. Consider the critical value $c_{n}(\bar{h}, \alpha)$ based on the penalized bootstrap procedure

where the random variable $R_{n}^{*}$, conditional on the data, is defined as

R_{n}^{*} \equiv \inf _{\theta \in \Theta(\bar{h})} \max _{j \in[p]} \underbrace{\frac{1}{\sqrt{n}} \sum_{i=1}^{n} g_{i} \frac{m_{j}\left(W_{i}, \theta\right)-\bar{m}_{\theta, j}}{\hat{\sigma}_{\theta, j}}}_{\text {zero-mean Gaussian process }}+\kappa_{n}^{-1} \underbrace{\frac{\sqrt{n} \bar{m}_{\theta, j}}{\hat{\sigma}_{\theta, j}}}_{\text {centering }} \tag{3.2}
\end{equation*}
$$

where $\kappa_{n}$ is a tuning parameter, and $\left(g_{i}\right)_{i=1}^{n}$ are i.i.d. standard Gaussian random variables. It has been noted in the literature that the centering term cannot be consistently estimated in a uniformly fashion. Therefore the use of $\kappa_{n}=1$ would not make (3.1) a valid choice. In (3.1) we set $\kappa_{n}$ to dominate the effective noise in the centering, namely

\bar{w}_{n} \geq \sup _{\theta \in \Theta(\bar{h})} \max _{j \in[p]}\left|\sqrt{n} \hat{\sigma}_{\theta, j}^{-1}\left\{\bar{m}_{\theta, j}-\mathrm{E}\left[m_{j}(W, \theta)\right]\right\}\right|
$$

with high probability. With that in mind we keep $\kappa_{n}$ as small as possible not to remove the true centering $\sqrt{n} \hat{\sigma}_{\theta, j}^{-1} \mathrm{E}\left[m_{j}(W, \theta)\right]$ completely (because the minimum over $\theta$ would lead to a too small critical value). We note that because of the many inequalities setting, we typically have $\bar{w}_{n} \rightarrow \infty{ }^{6}$

Moreover, the approximation errors of the new coupling results should not affect the size. Letting $\delta_{n}$ denote such coupling approximation error, we have that

\mathrm{P}\left(T_{n}(\bar{h}) \geq c_{n}(\bar{h}, \alpha)\right) & \leq \mathrm{P}\left(R_{n}^{*} \geq c_{n}(\bar{h}, \alpha)-\delta_{n}\right)+C n^{-c} \\
& \leq \alpha+\mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq \delta_{n}\right)+C n^{-c} .
\end{aligned}
$$

The validity of the bootstrap approximation is guaranteed by $\mathrm{P}\left(\mid R_{n}^{*}-\right.$ $\left.c_{n}(\bar{h}, \alpha) \mid \leq \delta_{n}\right) \rightarrow 0$. In other words, the distribution of $R_{n}^{*}$ should not concentrate too much mass around $c_{n}(\bar{h}, \alpha)$ as $n$ diverges. It is not hard to show that this concentration is bounded by $\delta_{n}$ multiplied by the maximum value of the density function of $R_{n}^{*}$. In moment inequality models with fixed number of moment conditions, this does not pose any problems as the limit of the corresponding density function is typically bounded. However, in moment inequality models with many moment inequalities, these statistics can

[^4]have very different behavior. For example, Chernozhukov et al. [25] show that the distribution of the Maximum statistic can concentrate but not too fast. Indeed it is shown that maximum density of the Maximum statistic is bounded by a logarithmic factor of the number of moment conditions $p$. In this paper, we are interested in the concentration properties associated to the MinMax statistic. Based on the previous derivation, we define unconditional and conditional anti-concentration parameters associated with $R_{n}^{*}$ as follows:

\mathcal{A}_{n} \equiv \sup _{\epsilon \geq \delta_{n}} \frac{1}{\epsilon} \mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq \epsilon\right) .  \tag{3.3}\\
\mathcal{A}_{n}(W) \equiv \sup _{\epsilon \geq \delta_{n}} \frac{1}{\epsilon} \mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq \epsilon \mid\left(W_{i}\right)_{i=1}^{n}\right) . \tag{3.4}
\end{gather*}

Importantly, the anti-concentration property that is needed pertains to the bootstrap-based statistic $R_{n}^{*}$, and not the original statistics $T_{n}(\bar{h})$. Because of this feature, we can investigate $\mathcal{A}_{n}$ via bootstrap of the quantity $\mathcal{A}_{n}(W)$ conditionally on the data. This approximation is described in detail in Section 5.

The corollary below shows that the choice of critical value (3.1) effectively controls the size, in the sense of (2.9), uniformly over a set of data generating processes. The conditions are simple to allow easier interpretability but allows for the many inequality setting with potentially $p \gg n$. (Our results hold much more generally as stated in Theorems 1 and 2.)

Corollary 1. Assume that (i) $m_{j}$ and its componentwise derivatives are uniformly bounded by $C_{1},{ }^{7}$ (ii) $\Theta(\bar{h})$ is convex and uniformly bounded in $\ell_{\infty}$-norm, ${ }^{8}$ (iii) $\inf _{j \in[p], \theta \in \Theta(\bar{h})} \operatorname{Var}\left(m_{j}(W, \theta)\right) \geq c_{1}$ and (iv) that a polynomially minorant condition holds with $\vartheta_{n} \geq c_{1}$ and $\delta \geq c_{1} .{ }^{9}$ Also assume that $\kappa_{n}$ satisfies

\left(\frac{\log ^{4}\left(p n^{d_{\theta}}\right)}{n}\right)^{1 / 6}+\kappa_{n} \frac{d_{\theta}^{1 / 2} \log \left(p n^{d_{\theta}}\right)}{n^{1 / 2}}+\frac{\bar{w}_{n}}{\kappa_{n}} \leq \frac{C_{2} n^{-c_{2}}}{\mathcal{A}_{n}} \tag{3.5}
\end{equation*}

where $\bar{w}_{n}$ is the $\left(1-n^{-c_{2}}\right)$-quantile of the effective noise. Then, under $H_{0}$,

\mathrm{P}\left(T_{n}(\bar{h}) \geq c_{n}(\bar{h}, \alpha)\right) \leq \alpha+C n^{-c},
$$

where $c$ and $C$ are constants that depend only on $c_{1}, C_{1}, c_{2}, C_{2}$.

Corollary 1 provides low-level conditions that apply to many cases of practical interest. For example, it includes moment conditions that are Lipschitz continuous and it allows the dimension of the parameter space $d_{\theta}$ and the number of moment inequalities to grow with the sample size. In particular, it allows for $p \gg n$.

EXAMPLE 1 (Polynomially many inequalities and large $d_{\theta}$ ). In addition to conditions (i)-(iv) in Corollary 1, assume that $p=n^{C}$ for some fixed $C>1, d_{\theta}=n^{a}$ for some $a<1 / 4$, and that the anti-concentration parameter satisfies $\mathcal{A}_{n} \leq C \log ^{3 / 2} n$. Then, condition (3.5) holds provided $\kappa_{n}=n^{b}$ for any $b \in\left(\frac{1}{2} a, \frac{1}{2}-\frac{3}{2} a\right)$.

Example 2 (Exponentially many inequalities). In addition to conditions (i)-(iv) in Corollary 1, assume that $p \geq n^{\log n}$, $d_{\theta} \leq C \log n$, and the anti-concentration parameter satisfies $\mathcal{A}_{n} \leq C \log ^{3 / 2} p$. Then, condition (3.5) holds if $\kappa_{n} \in\left[n^{c_{2}} \log ^{2} p, n^{1 / 2-c_{2}} \log ^{-5 / 2} p\right]$, and $n^{-1 / 6+c_{2}} \log ^{13 / 6} p=$ $o(1)$.

Corollary 1 requires the choice of $\kappa_{n}$ to be appropriate. Such requirements generalize the requirements in Bugni et al. [21] where it was required $\kappa_{n} \rightarrow$ $\infty$ and $\sqrt{n} / \kappa_{n} \rightarrow \infty$. Theorem 2 characterizes the finite sample impact of $\kappa_{n}$ for a non-Donsker class of functions. Theorem 2 also motivates data driven choices of $\kappa_{n}$ that accounts for the anti-concentration of the process $R_{n}^{*}$ which might be non-trivial since $\mathcal{A}_{n}$ could grow.

The bootstrap procedure discussed above and the others studied in Section 4.1 adapt to the correlation structure of the process to improve power. However, that is achieved by levering conditions on the number of inequalities $p$, sample size $n$, effective noise $\bar{w}_{n}$, and anti-concentration $\mathcal{A}_{n}$.

An alternative approach is to rely on union bounds that are more conservative but are valid under weaker conditions. Moreover, since the bounds are based on the marginal distribution, there is no need to handle the anticoncentration. With that in mind, similarly to Chernozhukov et al. [25], ideas from self-normalized moderate deviation theory can be applied to control size as we describe next. By construction of the test statistics $T_{n}(\bar{h})$ satisfies

\end{equation*}

Moreover, $H_{0}$ implies that $\mathrm{E}\left[m_{j}\left(W_{i}, \theta^{*}\right)\right] \leq 0$, and when combined with the
union bound we have
$\mathrm{P}\left(T_{n}(\bar{h})>c_{n}(\bar{h}, \alpha)\right) \leq \sum_{j=1}^{p} \mathrm{P}\left(\sum_{i=1}^{n} \frac{m_{j}\left(W_{i}, \theta^{*}\right)-\mathrm{E}\left[m_{j}\left(W_{i}, \theta^{*}\right)\right]}{\sqrt{n} \hat{\sigma}_{\theta^{*}, j}}>c_{n}(\bar{h}, \alpha)\right)$,
where the last sum is approximately self-normalized. Such self-normalization has been exploited in the moderate deviation literature to establish central limit theorems that are valid in the tails of the distribution under mild moment conditions, see e.g. de la Peña et al. [37]. In turn this leads to pivotal choices for the critical value to control size of the test by setting

c_{n}(\bar{h}, \alpha) \approx \Phi^{-1}(1-\alpha / p) .
$$

Since $c_{n}(\bar{h}, \alpha)$ is of the order of $\sqrt{\log (p / \alpha)}$, it grows in the many moment inequality setting where $p \rightarrow \infty$. Therefore the Gaussian approximation should hold sufficiently deep in the tails to include $c_{n}(\bar{h}, \alpha)$. This leads to the restriction $\log ^{3}(p / \alpha)=o(n)$ under suitable moment requirements. The following corollary of Theorem 4 provides a result.

Corollary 2. Assume that $H_{0}$ holds, i.e., $\theta^{*} \in \Theta(\bar{h})$, and that the are constants $0<c_{1}<1 / 2$ and $C_{1}>0$ such that $\max _{j \in[p]} \mathrm{E}\left[\left|m_{j}\left(W, \theta^{*}\right)\right|^{3}\right] \leq C_{1}$, $\min _{j \in[p]} \operatorname{Var}\left(m_{j}\left(W, \theta^{*}\right)\right) \geq c_{1}$, and $\log ^{3 / 2}(p / \alpha) \leq C_{1} n^{1 / 2-c_{1}}$. Then,

\mathrm{P}\left(T_{n}(\bar{h})>c_{n}(\bar{h}, \alpha)\right) \leq \alpha+C n^{-c},
$$

where $c$ and $C$ are constants that depend only on other constants of the problem.

We also consider two-step versions of the self-normalization procedure that can improve power relative to the self-normalization procedure described above. However, because of the MinMax structure, substantial departure from Chernozhukov et al. [25] is needed to establish the validity of a proposed critical value. These described in detail in Section 4.2.
4. Critical Values and Theoretical Guarantees. In this section, we propose several methods to construct critical values $c_{n}(\bar{h}, \alpha)$ in the hypothesis test procedure in (2.7). We consider critical values based on the bootstrap approximations and based on self-normalized moderate deviation approximations. While the resulting hypothesis tests are shown to control asymptotic size, they have different power properties and are asymptotically valid under different conditions.
4.1. Bootstrap-based critical values. In the following subsections we propose and analyze bootstrap-based method for the construction of critical values that appropriately control size despite the high-dimensionality of the process being considered. For each $\theta \in \Theta$ and $j \in[p]$, we will denote the bootstrap process

\begin{equation*}
\hat{v}_{\theta, j}^{*} \equiv \frac{1}{\sqrt{n}} \sum_{i=1}^{n} \xi_{i}\left\{m_{j}\left(W_{i}, \theta\right)-\bar{m}_{\theta, j}\right\} / \hat{\sigma}_{\theta, j}, \tag{4.1}
\end{equation*}

where $\left(\xi_{i}\right)_{i=1}^{n}$ are i.i.d. $N(0,1)$ random variables independent of the data $\left(W_{i}\right)_{i=1}^{n}$. We will make the following assumption to analyse the bootstrap based critical values.
Condition MB. The set $\Theta(\bar{h})$ is convex and the following conditions hold: (i) $\|\theta\|_{\infty} \leq \sqrt{n}$ and $\max _{j \in[p]}\left\|\nabla_{\theta} \mathrm{E}\left[m_{j}(W, \theta)\right] / \sigma_{\theta, j}\right\| \leq L_{G}$ for every $\theta \in$ $\Theta(\bar{h})$. The set of functions $\left\{m_{j}(\cdot, \theta) / \sigma_{\theta, j}: \theta \in \Theta(\bar{h}), j \in[p]\right\}$ is VC type with measurable envelope $F$ and constants $\bar{A}$ and $v \geq 1 .{ }^{10}$ Moreover, for constants $b \geq \sigma>0$ we have $\sup _{\theta \in \Theta(\bar{h})} \max _{j \in[p]} \mathrm{E}\left[\left|m_{j}(W, \theta) / \sigma_{\theta, j}\right|^{k}\right] \leq \sigma^{2} b^{k-2}$, $k=2,3,4$, and $\mathrm{E}\left[F^{q}\right]^{1 / q} \leq b$ for $q>6$. (ii) $\max _{j \in[p]} \mathrm{E}\left[\left\{m_{j}(W, \theta) / \sigma_{\theta, j}-\right.\right.$ $\left.\left.m_{j}(W, \tilde{\theta}) / \sigma_{\tilde{\theta}, j}\right\}^{2}\right] \leq L_{C}\|\theta-\tilde{\theta}\|^{\chi}$ for every $\theta, \tilde{\theta} \in \Theta(\bar{h})$ for some $\chi \geq 1$. (iii) For every $\theta \in \Theta(\bar{h}) \backslash \Theta_{I}$ we have

$$
\max _{j \in[p]} \mathrm{E}\left[m_{j}(W, \theta)\right] / \sigma_{\theta_{n}, j} \geq \vartheta_{n} \min \left\{\delta, \inf _{\tilde{\theta} \in \Theta(\bar{h}) \cap \Theta_{I}}\|\theta-\tilde{\theta}\|\right\} .
$$

These conditions impose the existence of fourth moments of $m_{j}(W, \theta) / \sigma_{\theta, j}$ for each $j \in[p]$ and $\theta \in \Theta$. It also states that the functions $m_{j}(\cdot, \theta) / \sigma_{\theta, j}$ are well behaved in the sense of being a VC type, which covers a many applications of interest. Condition $\mathrm{MB}(\mathrm{iii})$ is a polynomial minorant condition as we move away from the identified set similar to the conditions imposed in Chernozhukov et al. [24] and Bugni et al. [21]. However, we also allow for the parameter $\vartheta_{n} \rightarrow 0$ in our analysis.

For a sequence $\gamma_{n}=o(1)$, we define

& K_{n} \equiv\left(d_{\theta} / \chi\right) \log \left(n L_{G}\right)+v(\log n \vee \log (p \bar{A} b / \sigma)) . \tag{4.4}
\end{align*}

Throughout the paper we will typically consider $\gamma_{n}=n^{-c}$ for a suitably small constant $c>0$. In words, $\bar{w}_{n}$ is an effective measure of the noise in

[^5]the problem, $t_{n}^{\sigma}$ is a uniform rate of convergence for the estimation of the standard deviation on the moment conditions, and $K_{n}$ controls the entropy associated with the class of functions induced by the moment conditions. Importantly, we will be able to approximate $\bar{w}_{n}$ via bootstrap simulations of the Gaussian process $\left\{\hat{v}_{\theta, j}^{*}: \theta \in \Theta, j \in[p]\right\}$ conditional on the data. Under mild conditions, we have that $\bar{w}_{n} \lesssim \sqrt{d_{\theta} \log \left(p n / \gamma_{n}\right)}$ and $t_{n}^{\sigma} \bar{w}_{n}=o(1)$.
4.1.1. Discard Resampling or $D R$ Bootstrap. The first strategy to construct critical values is based on a bootstrap procedure that discards parameter values and moment inequalities that are problematic for an asymptotic approximation. The definition of this bootstrap statistic requires certain sample objects. For some sequence $M_{n} \geq \bar{w}_{n}$, let:

By definition, $\widehat{\Theta}_{n}(\bar{h})$ is an arbitrary non-empty subset of the minimizers that define the MinMax statistic and, for each $\theta \in \Theta, \widehat{\Psi}_{\theta}$ denotes the subset of the moment inequalities that are sufficiently close to being binding. In principle, we can choose $\widehat{\Theta}_{n}(\bar{h})$ to be any of the minimizers that define the MinMax statistic.

The DR bootstrap statistic is defined as follows:

where $\hat{v}_{\theta, j}^{*}$ is the Gaussian multiplier bootstrap defined in (4.1). For $\alpha \in$ $(0,1)$, we define the corresponding conditional critical value as follows:

The following result establishes the relationship between the original MinMax statistic and the DR bootstrap statistic, and it exploits this result to show the asymptotic validity of the DR bootstrap approximation.

Theorem 1. Assume that Condition MB is satisfied, $K_{n}^{3} \leq n$, and that $M_{n} / \bar{w}_{n} \geq\left(L_{G} / \vartheta_{n}+4+t_{n}^{\sigma} 4 / 3\right) 2\left(1+t_{n}^{\sigma}\right)^{2} /\left(1-t_{n}^{\sigma}\right)^{2}$. Then, under $H_{0}$,

where $c$ and $C$ are constants that depend only on other constants of the problem, and

\delta_{n}^{D R} \equiv \frac{C b \sigma^{2} K_{n}}{\gamma_{n}^{3 / q} n^{1 / 2}}+\frac{C\left(b \sigma^{2} K_{n}^{2}\right)^{1 / 3}}{\gamma_{n}^{1 / 3} n^{1 / 6}}+C L_{C}^{1 / 2}\left(\frac{C \sigma K_{n}^{1 / 2}}{\gamma_{n}^{1 / q} n^{1 / 2} \vartheta_{n}}\right)^{\chi / 2} \frac{K_{n}^{1 / 2}}{\gamma_{n}^{1 / q}}+\frac{C b K_{n}}{\gamma_{n}^{1 / q} n^{1 / 2-1 / q}}
$$

Moreover, we have

\mathrm{P}\left(T_{n}(\bar{h})>c_{n}^{D R}(\bar{h}, \alpha)\right) \leq \alpha+C \mathcal{A}_{n}^{D R} \delta_{n}^{D R}+C\left\{\gamma_{n}+n^{-1}\right\}
$$

where $\mathcal{A}_{n}^{D R}$ is as in (3.3) but with $R_{n}^{*}, c_{n}(\bar{h}, \alpha)$, and $\delta_{n}$ replaced by $R_{n}^{D R *}$ and $c_{n}^{D R}(\bar{h}, \alpha)$, and $\delta_{n}^{D R}$, respectively.

Theorem 1 shows how the tail probability of the statistic of interest can be bounded by the tail probability of the bootstrap statistic (up to an approximation error). The result allows for both $p$ and $d_{\theta}$ to increase with the sample size. In particular, $p \gg n$ is allowed. However, our proof of the validity of this procedure requires the choice of $M_{n}$ to be such that binding inequalities are not missed. In particular, it would suffice to choose $M_{n}$ such that $M_{n} / \bar{w}_{n} \rightarrow \infty$ in cases where $\vartheta_{n} \geq c$ and $L_{G} \leq C$, which are common in applications. Importantly, we can rigorously approximate $\bar{w}_{n}$ as the $1-n^{-c}$ quantile of $\sup _{\theta \in \Theta(\bar{h}), j \in[p]}\left|\hat{v}_{\theta, j}^{*}\right|$ which provides a data-driven approach to set $M_{n}$. Note that this represents an additional restriction relative to $M_{n} \rightarrow \infty$ required by Bugni et al. [21] in the context of finite number of moment inequalities. ${ }^{11}$ Instead, our requirement that $M_{n} / \bar{w}_{n} \rightarrow \infty$ indicates that $M_{n}$ is adaptive to the setting under consideration.

To guarantee that the DR bootstrap approximation provides asymptotic size control we require that $\gamma_{n}+\mathcal{A}_{n}^{D R} \delta_{n}^{D R} \approx 0$, i.e., the distribution DR bootstrap statistic cannot concentrate excessively at the quantile of interest relative to the approximation error $\delta_{n}^{D R}$. (See Section 5 for further discussion.) The following corollary of Theorem 1 provides simple sufficient conditions that covers many data generating process of interest.

Corollary 3. Assume that Condition MB holds, $K_{n}^{3} \leq n, L_{G} / \vartheta_{n} \leq$ $C_{1}, \bar{w}_{n} / M_{n} \leq \log ^{-1} n$, and that $\gamma_{n}+\mathcal{A}_{n}^{D R} \delta_{n}^{D R} \leq C_{1} n^{-c_{1}}$. Then, under $H_{0}$,

\mathrm{P}\left(T_{n}(\bar{h})>c_{n}^{D R}(\bar{h}, \alpha)\right) \leq \alpha+C n^{-c}
$$

where $c$ and $C$ are constants that depend only on other constants of the problem.

[^6]REMARK 2 (Anti-concentration). In cases where we choose $\widehat{\Theta}_{n}(\bar{h})$ to be a singleton, we can show that $\mathcal{A}_{n}^{D R} \leq C \log ^{1 / 2} p$ by the known anticoncentration properties associated with the maximum of Gaussian variables. Moreover, we have $\mathcal{A}_{n}^{D R}(W) \leq C\left\{\log \left(1+\left|\widehat{\Psi}_{\hat{\theta}}\right|\right)\right\}^{1 / 2} \leq C \log ^{1 / 2} p$. Moreover, Lemma 9 in the appendix shows that if the cardinality of $\widehat{\Theta}_{n}(\bar{h})$ is bounded by $k$, then we have $\mathcal{A}_{n}^{D R} \leq C k \log ^{1 / 2} p$. ${ }^{12}$
4.1.2. Penalized Resampling or $P R$ Bootstrap. The second strategy to construct critical values is based on a bootstrap procedure that takes into account the non-centered feature of the empirical process via penalization. The Penalized Resampling or PR bootstrap statistic is defined as follows

R_{n}^{P R *} \equiv \inf _{\theta \in \Theta(\bar{h})} \max _{j \in[p]}\left\{\hat{v}_{\theta, j}^{*}+\kappa_{n}^{-1} \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j}\right\} \tag{4.6}
\end{equation*}
$$

where $\kappa_{n} \geq 1$ is a user-specified tuning parameter and the $\hat{v}_{\theta, j}^{*}$ is the bootstrap process defined in (4.1). For $\alpha \in(0,1)$, we define the corresponding conditional critical value as follows:

Similarly to Theorem 1, the following result establishes the relationship between the original MinMax statistic and the PR bootstrap statistic, and it exploits this result to show the asymptotic validity of the PR bootstrap approximation.

Theorem 2. Assume that Condition $M B$ is satisfied and $K_{n}^{3} \leq n$. Then, under $H_{0}$,

where $c$ and $C$ are constants that depend only on other constants of the problem, and

\delta_{n}^{P R} \equiv \frac{L_{G} \kappa_{n} \sigma^{2} K_{n}}{\gamma_{n}^{2 / q} n^{1 / 2} \vartheta_{n}^{2}}+\frac{\left(b \sigma^{2} K_{n}^{2}\right)^{1 / 3}}{\gamma_{n}^{1 / 3} n^{1 / 6}}+\frac{(b \sigma)^{1 / 2} K_{n}^{3 / 4}}{\gamma_{n}^{1 / q} n^{1 / 4}}+\frac{b K_{n}}{\gamma_{n}^{1 / q} n^{1 / 2-1 / q}} \\
+\frac{\bar{w}_{n}}{\kappa_{n}}+L_{C}^{1 / 2}\left(\frac{\kappa_{n} \sigma K_{n}^{1 / 2}}{n^{1 / 2} \vartheta_{n} \gamma_{n}^{1 / q}}\right)^{\chi / 2} \frac{K_{n}^{1 / 2}}{\gamma_{n}^{1 / q}}

$$

where $\mathcal{A}_{n}^{P R}$ is as in (3.3) but with $R_{n}^{*}, c_{n}(\bar{h}, \alpha)$, and $\delta_{n}$ replaced by $R_{n}^{P R *}$ and $c_{n}^{P R}(\bar{h}, \alpha)$, and $\delta_{n}^{P R}$, respectively.

Theorem 2 bounds the probability distribution function of $T_{n}(\bar{h})$ based on approximation errors and the probability distribution of $R_{n}^{P R_{*}}$. The core of the proof constructs intermediary processes for which we can apply Theorems 8 and 9 . Theorem 2 also provides guideline on how to choose $\kappa_{n}$. Indeed we need to ensure that $\kappa_{n} / \bar{w}_{n} \rightarrow \infty$ and $n^{-1 / 2} \kappa_{n}\left(L_{G} \sigma^{2} K_{n} / \vartheta_{n}^{2}\right) \rightarrow 0$. These highlights the role of considering many moment inequalities on the threshold sequence. In fact, the moment inequality literature with a fixed number of moment conditions typically just requires that $\kappa_{n} \rightarrow \infty$ and $n^{-1 / 2} \kappa_{n} \rightarrow 0$.

Provided that $\gamma_{n}$ such as $\gamma_{n}+\delta_{n}^{P R} \mathcal{A}_{n}^{P R} \leq C_{2} n^{-c_{2}}$, Theorem 2 implies that the critical value based on the PR bootstrap approximation provides asymptotic size control. However, note that the anti-concentration condition impacts the choice of threshold sequence $\kappa_{n}$ as it impact $\delta_{n}^{P R}$. (See Section 5.) Corollary 1 stated earlier provided conditions under which we obtain (2.9).

Remark 3 (Refinements on centering). For the vector inference problem, Romano et al. [50] discussed an alternative approach to incorporate the centering in the bootstrap-based statistics. Also, see the discussion in Comment 4.4 in Chernozhukov et al. [25]. In the vector inference problem, the hypothesis $H_{0}: \theta^{*}=\bar{\theta}$ completely specifies the true parameter value. Letting $\mu_{j}=\mathrm{E}\left[m_{j}\left(\bar{\theta}, W_{1}\right)\right]$, the value $\tilde{\mu}_{j}=\min \left\{0, \hat{\mu}_{j}+\hat{\sigma}_{j} \bar{c}_{n} / \sqrt{n}\right\}$ which satisfies $\mu_{j} \leq \tilde{\mu}_{j}$ with probability exceeding $1-\gamma_{n}$ under $H_{0}$ by taking $\bar{c}_{n}$ as the $1-\gamma_{n}$ quantile of the effective noise $\max _{j \in[p]} \sqrt{n}\left(\hat{\mu}_{j}-\mu_{j}\right)$. Thus $\sqrt{n} \tilde{\mu}_{j} / \hat{\sigma}_{j}$ can be used as a valid centering for the vector inference problem to construct critical values. In the subvector inference problem considered in this paper, we have $\mathrm{E}\left[m_{j}(W, \theta)\right] \leq \bar{m}_{\theta, j}+\hat{\sigma}_{\theta, j} \bar{w}_{n} / \sqrt{n}$ for all $\theta \in \Theta(\bar{h})$ and $j \in[p]$ with probability exceeding $1-\gamma_{n}$. However, we cannot take the minimum with zero as $H_{0}: h\left(\theta^{*}\right)=\bar{h}$ does not completely specify completely true parameter value. When compared with the recentered used in the PR bootstrap as defined in (4.6), we note that neither recentering

$$
\kappa_{n}^{-1} \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j} \quad \text { and } \quad \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j}+\bar{w}_{n}
$$

dominates each other in general. Indeed, the recentering for the $P R$ bootstrap will be smaller if and only if

$$
-\bar{w}_{n}<\left(1-\kappa_{n}^{-1}\right) \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j} .
$$

Therefore we can take a recentering

$$
\min \left\{\kappa_{n}^{-1} \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j}, \quad \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j}+\bar{w}_{n}\right\} .
$$

The analysis of a bootstrap procedure based on this recentering follows essentially the same proof as of the penalized bootstrap and therefore it is omitted.

Remark 4 (Data-driven choice of $\kappa_{n}$ ). Implicitly, both the PR bootstrap statistic $R_{n}^{P R *}=R_{n}^{P R *}\left(\kappa_{n}\right)$ and its anti-concentration parameters $\mathcal{A}_{n}^{P R}=$ $\mathcal{A}_{n}^{P R}\left(\kappa_{n}\right)$ and $\mathcal{A}_{n}^{P R}\left(W, \kappa_{n}\right)$ depend on the threshold sequence $\kappa_{n}$. The following is an implementable procedure to make an adaptive data-driven choice for $\kappa_{n}$.

Step 1. Approximate $\bar{w}_{n}$ as the $1-n^{-c}$ quantile of $\sup _{\theta \in \Theta(\bar{h}), j \in[p]}\left|\hat{v}_{\theta, j}^{*}\right|$.
Step 2. Compute the anti-concentration parameter $\mathcal{A}_{n}^{P R}(W, \kappa)$ of $R_{n}^{P R *}(\kappa)$.
Step 3. Define $\kappa_{n} \equiv \inf \left\{\kappa: \kappa \geq \bar{w}_{n} \mathcal{A}_{n}^{P R}(W, \kappa) n^{c}\right\}$.
Step 4. Compute critical value $c_{n}^{P R}(\bar{h}, \alpha)$ based on $R_{n}^{P R *} \equiv R_{n}^{P R *}\left(\kappa_{n}\right)$.
4.1.3. Minimum Resampling or MR Bootstrap. We can combine the two previous bootstrap approximations by taking the minimum of their bootstrap statistics. Formally, the Minimum Resampling or MR bootstrap statistic is defined as follows:

R_{n}^{M R *}=\min \left\{R_{n}^{D R *}, R_{n}^{P R *}\right\} .
$$

For $\alpha \in(0,1)$, we define the corresponding critical values as follows

$$
c_{n}^{M R *}(\bar{h}, \alpha)=\text { conditional }(1-\alpha) \text {-quantile of } R_{n}^{M R *} \text { given }\left(W_{i}\right)_{i=1}^{n} .
$$

The following result builds on Theorems 1 and 2. It establishes a relationship between the original MinMax statistic $T_{n}(\bar{h})$ and the MR bootstrap statistic $R_{n}^{P R *}$, and it shows the asymptotic validity of the MR bootstrap approximation.

Theorem 3. Assume that the conditions in Theorems 1 and 2 hold. Then, under $H_{0}$,

$$
\mathrm{P}\left(T_{n}(\bar{h}) \geq t\right) \leq \mathrm{P}\left(R_{n}^{M R *} \geq t-C \delta_{n}^{M R}\right)+C\left\{\gamma_{n}+n^{-1}\right\},
$$

where $c$ and $C$ are constants that depend only on other constants of the problem, $\delta_{n}^{M R} \equiv \delta_{n}^{D R}+\delta_{n}^{P R}$, and $\delta_{n}^{D R}$ and $\delta_{n}^{P R}$ are as defined in Theorems 1 and 2, respectively. Moreover, we have

$$
\mathrm{P}\left(T_{n}(\bar{h}) \geq c_{n}^{M R}(\bar{h}, \alpha)\right) \leq \alpha+C \mathcal{A}_{n}^{M R} \delta_{n}^{M R}+C\left\{\gamma_{n}+n^{-1}\right\}^{1 / 2}
$$

where $\mathcal{A}_{n}^{M R}$ is as in (3.3) but with $R_{n}^{*}, c_{n}(\bar{h}, \alpha)$, and $\delta_{n}$ replaced by $R_{n}^{M R *}$ and $c_{n}^{M R}(\bar{h}, \alpha)$, and $\delta_{n}^{M R}$, respectively.

The proof of Theorem 3 shows how the finite sample analysis used here lands itself for the combination of valid procedures. The approach allows us to avoid considering the limit distribution and the issues associated with its existence. Indeed, we do not require the existence of a distributional limit but instead control approximation errors for each $n$.
4.2. Self-Normalization based Critical Values. In this section, we discuss inference using critical values based on self-normalized moderate deviation theory. Although the resulting inference is potentially more conservative than the one based on the bootstrap, the method is easier to compute and asymptotically valid for a wider class of data generating processes.

The self-normalized inference was originally proposed by Chernozhukov et al. [25] in the context of inference on the parameter vector $\theta^{*}$ in the partially identified many moment inequality model. The ideas proposed in this section follow closely the arguments in Chernozhukov et al. [25].

For $\alpha \in(0,1)$, we define the self-normalized or SN critical value as follows:

$$
\begin{equation*}
c_{n}^{S N}(p, \alpha) \equiv \frac{\Phi^{-1}(1-\alpha / p)}{\sqrt{1-\Phi^{-1}(1-\alpha / p)^{2} / n}} \tag{4.7}
\end{equation*}
$$

where $\Phi$ is the cumulative distribution function of the standard normal distribution.

Theorem 4 (Validity of SN method). Assume that $H_{0}$ holds, i.e., $\theta^{*} \in$ $\Theta(\bar{h})$, and that there are constants $0<c_{1}<1 / 2$ and $C_{1}>0$ such that

$$
\max _{j \in[p]} \mathrm{E}\left[\left|\sigma_{\theta^{*}, j}^{-1}\left\{m_{j}\left(W, \theta^{*}\right)-\mathrm{E}\left[m_{j}\left(W, \theta^{*}\right)\right]\right\}\right|^{3}\right] \log ^{3 / 2}(p / \alpha) \leq C_{1} n^{1 / 2-c_{1}}
$$

Then,

$$
\mathrm{P}\left(T_{n}(\bar{h})>c_{n}^{S N}(p, \alpha)\right) \leq \alpha+C n^{-c}
$$

where $c$ and $C$ are constants that depend only on $\alpha, c_{1}, C_{1}$.

The proof of Theorem 4 follows from the proof of Theorem 4.1 in Chernozhukov et al. [25]. Note that the assumptions of Theorem 4 are only required to hold at the true parameter value $\theta^{*}$, rather than every $\theta \in \Theta(\bar{h})$.

Next, we discuss a two-step version of the SN procedure. Similar to analogous procedures defined in Chernozhukov et al. [25], our two-step SN procedure takes advantage of restricting attention to relevant parameter values
and moment inequalities. However, unlike the two-step procedure defined in Chernozhukov et al. [25], our two-step SN procedure takes into account the fact that $H_{0}$ does not completely specify the true parameter vector $\theta^{*}$.

For every $\theta \in \Theta(\bar{h})$, and $\gamma_{n} \in(0, \alpha / 4)$ define the following objects:

\begin{aligned}
\hat{J}_{n}^{S N}(\theta) & \equiv\left\{j \in[p]: \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{j}(\theta)>-2 c_{n}^{S N}\left(p, \gamma_{n}\right)\right\} \\
c_{n}^{S N, 2 S}(\theta, \alpha) & \equiv\left\{\begin{array}{rr}
\frac{\Phi^{-1}\left(1-\left(\alpha-3 \gamma_{n}\right) /\left|\hat{S}_{S}^{S N}(\theta)\right|\right.}{\sqrt{1-\Phi^{-1}\left(1-\left(\alpha-3 \gamma_{n}\right)\left|\hat{J}_{n}^{S N}(\theta)\right|\right)^{2} / n}}, & \text { if }\left|\hat{J}_{n}^{S N}(\theta)\right| \geq 1, \\
0, & \text { if }\left|\hat{J}_{n}^{S N}(\theta)\right|=0 .
\end{array}\right. \\
\widehat{\Theta}_{n}^{S N} & \equiv\left\{\theta \in \Theta(\bar{h}): \max _{j \in[p]} \sqrt{n} \bar{m}_{\theta, j} / \hat{\sigma}_{\theta, j} \leq c^{S N}\left(p, \gamma_{n}\right)\right\} .
\end{aligned}
$$

For every candidate parameter $\theta \in \Theta(\bar{h}), \hat{J}_{n}^{S N}(\theta)$ is the subset of moment inequalities that are sufficiently close to binding and $c_{n}^{S N, 2 S}(\theta, \alpha)$ is the twostep SN critical value associated with the parameter value $\theta$. Finally, $\widehat{\Theta}_{n}^{S N}$ is a subset of $\Theta(\bar{h})$ that is sufficiently close to the identified set.

Theorem 5 (Validity of two-step SN method). Assume that $H_{0}$ holds, i.e., $\theta^{*} \in \Theta(\bar{h}), \gamma_{n} \in(0, \alpha / 4)$, and that there are constants $0<c_{1}<1 / 2$ and $C_{1}>0$ such that

$$
\begin{array}{r}
\max _{j \in[p]} \mathrm{E}\left[\left|\sigma_{\theta^{*}, j}^{-1}\left\{m_{j}\left(W, \theta^{*}\right)-\mathrm{E}\left[m_{j}\left(W, \theta^{*}\right)\right]\right\}\right|^{3}\right] \log ^{3 / 2}(p / \alpha) \leq C_{1} n^{1 / 2-c_{1}} \\
\left\{\mathrm{E}\left[\max _{j \in[p]}\left|\sigma_{\theta^{*}, j}^{-1}\left\{m_{j}\left(W, \theta^{*}\right)-\mathrm{E}\left[m_{j}\left(W, \theta^{*}\right)\right]\right\}\right|^{4}\right]\right\}^{1 / 2} \log ^{2}\left(p / \gamma_{n}\right) \leq C_{1} n^{1 / 2-c_{1}} .
\end{array}
$$

Then,

$$
\mathrm{P}\left(T_{n}(\bar{h})>\max _{\theta \in \widehat{\Theta}_{n}^{S N}} c_{n}^{S N, 2 S}(\theta, \alpha)\right) \leq \alpha+C n^{-c}
$$

where $c$ and $C$ are constants that depend only on other constants of the problem.

Theorem 5 shows that the two-step approach provides asymptotic size control under mild conditions compared to the bootstrap-based methods. For example, we are not making polynomial minorant assumption as in Condition MB(iii). The need for taking the maximum over $\widehat{\Theta}_{n}^{S N}$ arises from the fact that $H_{0}$ does not completely determine the true parameter value. As in Theorem 4, note that the moment assumptions of Theorem 5 are only required to hold at the true parameter value $\theta^{*}$. The proof builds upon Theorem 4.2 in Chernozhukov et al. [25] but the additional selection over $\widehat{\Theta}_{n}^{S N}$ requires controlling additional approximation errors.
5. Anti-concentration and Data-driven estimates. In the highdimensional settings the statistics of interest might have no limiting distribution and the use of simulation procedures (e.g. bootstrap) are useful to approximate the distribution of the statistics of interest, except for some special pivotal statistics (e.g. Belloni and Chernozhukov [14] for quantile regression). However, even if the approximation has a vanishing error, such error can distort coverage. The anti-concentration property ensures that the random variable we aim to simulate does not concentrate too much at relevant points of the distribution. Unless the approximation errors introduced by the coupling procedures are of a smaller order of the rate in which the random variable concentrate, we cannot reliably use the simulated quantiles to approximate the quantile of the original statistics. The anti-concentration properties for the maximum of (correlated and non-centered) Gaussian random variables have been understood recently, see Chernozhukov et al. [30, 31]. This is a prime example which covers several applications of interest including the construction of simultaneous confidence bands in high-dimensional regression settings, e.g., Belloni et al. [15, 16].

REmARK 5 (Anti-concentration for the Max). Consider a p-dimensional Gaussian random vector $W \sim N(0, \Sigma), \Sigma_{j j}=1, j \in[p], p \geq 2$. It is known that $Z=\max _{j \in[p]} W_{j}$ concentrates around $\mathrm{E}[Z]$. However, although it concentrates it does not concentrate too fast. Indeed, the probability density function $f_{Z}$ of $Z=\max _{j \in[p]} W_{j}$ is bounded by $C \sqrt{\log p}$, see Chernozhukov et al. [30], so that

$$
\sup _{t \in \mathbb{R}} \mathrm{P}(|Z-t| \leq \epsilon) \leq \epsilon \max _{t^{\prime} \in \mathbb{R}} f_{Z}\left(t^{\prime}\right) \leq \epsilon C \sqrt{\log p}
$$

Such feature provides a bound on the impact of the approximation error of the coupling on the estimation of the probability distribution of the original process via the bootstrap process. In the case we couple a process for the maximum of $p$ functions, under typical assumptions, the approximation errors from the coupling techniques are of the order $n^{-1 / 6} \log ^{2 / 3} p$, so that we can reliably use the multiplier bootstrap provided $\left\{n^{-1 / 6} \log ^{2 / 3} p\right\}\left\{\log ^{1 / 2} p\right\}=$ $n^{-1 / 6} \log ^{7 / 6} p=o(1)$.

In this section we are concerned with the anti-concentration property associated with the MinMax statistic that we propose for the problem of subvector inference in partially identified models with many moment inequalities. In contrast to the Max operator, the MinMax operation is not a convex function of its arguments, and this has substantial implications for our derivations. The anti-concentration bounds based on the maximum
density function for the MinMax are qualitatively different than the case of the max discussed in Remark 5. The following lemma shows this in the case of the statistic $Z=\min _{k \in[N]} \max _{j \in[p]} W_{k j}$ where $W \in \mathbb{R}^{N \times p}$ is a random matrix with i.i.d. $N(0,1)$ entries.

Proposition 1. For $W_{k j} \sim N(0,1)$, i.i.d., $k \in[N], j \in[p]$, define the random variable $Z=\min _{k \in[N]} \max _{j \in[p]} W_{k j}$. Provided that $p / \sqrt{2 \pi}>$ $\log (N p) \geq 2$, we have that the probability density function $f_{Z}$ satisfies:

$$
\begin{aligned}
\text { (i) } \max _{t^{\prime} \in \mathbb{R}} f_{Z}\left(t^{\prime}\right) & \leq 2\{\sqrt{2}+2\} \log ^{3 / 2}(N p) \\
\text { (ii) } \max _{t^{\prime} \in \mathbb{R}} f_{Z}\left(t^{\prime}\right) & \geq\left\{\sqrt{2} \log ^{1 / 2}\left(\frac{p}{\sqrt{2 \pi} \log N}\right)-2\right\} \frac{\log (N)}{e}
\end{aligned}
$$

Proposition 1 shows that the concentration properties of the MinMax case is different than the concentration properties of the Max case even for i.i.d. standard normal random variables. In particular, Proposition 1(ii) shows that in the high-dimensional case with $p=N$, the probability density function has values of the order $\log ^{3 / 2} p$ which contrasts with the max operator. Indeed, the random variable $\max _{k, j \in[p]} W_{k j}$ has the maximum of its probability density function to be at most of the order of $\log ^{1 / 2} p$. Nonetheless, Proposition 1(i) suggests it is possible for the anti-concentration parameter to increase logarithmically with the number of moment inequalities $p$.

We propose a data-driven procedure to estimate the anti-concentration property associated with the statistic of interest. This is applicable not only to the MinMax functional but to other functionals. This is particularly relevant in settings where it is hard to derive analytical bounds or when such bounds might be conservative. Indeed in the case of standardized by noncentered processes it is likely that the statistics of interest (and their anticoncentration property) will depend on a subset of the process associated with points that are more likely to determine the statistics. In that case, even if theoretical bounds for how fast some statistics concentrate are available, they can be conservative. Therefore, the use of an adaptive tool can be desired.

We now note several features of the anti-concentration parameter $\mathcal{A}_{n}$ associated to a bootstrap statistic $R_{n}^{*}$, as defined in (3.3). First, note that the anti-concentration quantity defined in (3.3) trivially satisfies

$$
\mathcal{A}_{n} \leq \max _{t^{\prime} \in \mathbb{R}} f_{R_{n}^{*}}\left(t^{\prime}\right)
$$

but it could be much smaller. Second, it allows for the distribution of $R_{n}^{*}$ to have a point mass and still be nicely bounded as we restrict the size of the
smallest set. ${ }^{13}$ Third, we can construct upper bounds for $\mathcal{A}_{n}$ and $\mathcal{A}_{n}(W)$ by using a lower bound on $\delta_{n}$. In most cases of interest, $n^{-1 / 2}$ constitutes such a lower bound which makes upper bounding $\mathcal{A}_{n}(W)$ feasible.

A sufficient condition for the concentration of the statistics not to impact the size is $\mathcal{A}_{n} \delta_{n} \rightarrow 0$. This ensures that the process $R_{n}^{*}$ has suitable anticoncentration not to introduce additional size distortions because of the coupling approximation errors. The next proposition connects the control of distortions via the quantity $\mathcal{A}_{n}(W)$.

Theorem 6. Assume that the conditions in Theorems 1 and 2 hold. (i) Then, under $H_{0}$, with probability $1-C\left\{\gamma_{n}+n^{-1}\right\}$ we have

$$
\begin{aligned}
\mathrm{P}\left(T_{n}(\bar{h})>t\right) & \leq \mathrm{P}\left(R_{n}^{D R *}>t-C \delta_{n}^{D R} \mid\left(W_{i}\right)_{i=1}^{n}\right)+C\left\{\gamma_{n}+n^{-1}\right\} \\
\mathrm{P}\left(T_{n}(\bar{h})>c_{n}(\bar{h}, \alpha)\right) & \leq \alpha+C \mathcal{A}_{n}^{D R}(W) \delta_{n}^{D R}+C\left\{\gamma_{n}+n^{-1}\right\},
\end{aligned}
$$

(ii) Then, under $H_{0}$, with probability $1-C\left\{\gamma_{n}+n^{-1}\right\}$ we have

$$
\begin{aligned}
\mathrm{P}\left(T_{n}(\bar{h})>t\right) & \leq \mathrm{P}\left(R_{n}^{P R *}>t-C \delta_{n}^{P R} \mid\left(W_{i}\right)_{i=1}^{n}\right)+C\left\{\gamma_{n}+n^{-1}\right\} \\
\mathrm{P}\left(T_{n}(\bar{h})>c_{n}(\bar{h}, \alpha)\right) & \leq \alpha+C \mathcal{A}_{n}^{P R}(W) \delta_{n}^{P R}+C\left\{\gamma_{n}+n^{-1}\right\},
\end{aligned}
$$

Theorem 6 accounts for the fact that the selection of inequalities and centering are data-driven and therefore it does not follow from a direct application of Markov inequality and Theorems 1 and 2.

The next result shows how coupling results can be used to provide upper bounds on the unconditional anti-concentration quantity $\mathcal{A}_{n}$ based on the conditional anti-concentration quantity $\mathcal{A}_{n}(W)$ with high probability.

Theorem 7. Suppose that with probability $1-\gamma_{n}$ we have

$$
\mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq \epsilon\right) \leq \mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq \epsilon+\tilde{\delta}_{n} \mid\left(W_{i}\right)_{i=1}^{n}\right)+\gamma_{n}
$$

Then, with probability $1-\gamma_{n}$ we have

$$
\mathcal{A}_{n} \leq \mathcal{A}_{n}(W)\left(1+\tilde{\delta}_{n} / \delta_{n}\right)+\gamma_{n} / \delta_{n}
$$

Remark 6. We note that $\delta_{n}$ in the definition of the anti-concentration is based on the coupling of the original non-Gaussian process while $\tilde{\delta}_{n}$ is based on the coupling of the unconditional and conditional multiplier bootstrap in

[^8](C.12). In particular, note that $R_{n}^{*}$ is the MinMax of symmetric random variables which allows to improve the coupling bounds which leads $\tilde{\delta}_{n}$ to be of smaller order of magnitude than $\delta_{n}$, i.e. $\tilde{\delta}_{n}=o\left(\delta_{n}\right)$. Therefore, provided we set $\gamma_{n}=o\left(\delta_{n}\right)$, with high probability we obtain a meaningful bound to $\mathcal{A}_{n}$ based on $\mathcal{A}_{n}(W)$.

Although this procedure provides a way to conduct inference, theoretical bounds for the anti-concentration play an important role to inform of the requirements on the sample size that are needed for the overall validity of the procedure. Nonetheless, it is conceivable that in more complex applications the anti-concentration can vary substantially with the data generating process. To provide such additional adaptivity is precisely the goal of the proposed data-driven procedure.

Remark 7 (Global anti-concentration). Note that the anti-concentration (3.3) is a local measure of the anti-concentration around the point $c_{n}(\bar{h}, \alpha)$. Indeed, one could change our definition for a more global definition of anticoncentration such as $\sup _{t, \epsilon \geq n^{-1 / 2}} \frac{1}{2 \epsilon} \mathrm{P}\left(\left|R_{n}^{*}-t\right| \leq \epsilon \mid\left(W_{i}\right)_{i=1}^{n}\right)$. However, we choose the local definition of anti-concentration as the global version could be unnecessarily conservative.

Remark 8 (Alternative definitions of the data-driven estimator). Rather than (3.3), we could propose alternative data-driven estimators of the anticoncentration. For example, we could use $\bar{l}_{n} \equiv \inf \left\{l: \mathrm{P}\left(\left|R_{n}^{*}-c_{n}(\bar{h}, \alpha)\right| \leq l \mid\right.\right.$ $\left.\left.\left(W_{i}\right)_{i=1}^{n}\right) \leq m_{n}\right\}$ where $m_{n}=o(1)$ is a pre-specified sequence (e.g. $\log ^{-1} n$ ). Provided that $\delta_{n}=o\left(\bar{l}_{n}\right)$, no additional asymptotic size distortions are introduced.
6. Coupling for MinMax Functional. In this section we state results for coupling the MinMax of the sum of independent empirical processes with the MinMax of Gaussian processes. Such results are crucial in our analysis and may be of independent interest. They build upon and complement recent results on the literature for the maximum of processes due to Chernozhukov et al. [27, 28, 29, 30, 31].
6.1. MinMax of Empirical Processes. Let $B: \mathcal{F} \rightarrow \mathbb{R}$ be a given functional. For $\eta>0$, let $N_{B}(\eta)$ denote the cardinality of a minimum $\eta$-cover of $\mathcal{F}$, i.e., $N_{B}(\eta)$ is the minimal integer $N$ such that there exist $f_{1}, \ldots, f_{N} \in \mathcal{F}$ with the property that for every $f \in \mathcal{F},\left|B(f)-B\left(f_{j}\right)\right|<\eta$ for some $j \leq N$. In what follows, we let $\left(X_{i}\right)_{i=1}^{n}$ be i.i.d. random processes mapping $\mathcal{F} \rightarrow \mathbb{R}$, and we define $\mathbb{G}_{n}(f) \equiv n^{-1 / 2} \sum_{i=1}^{n}\left\{X_{i}(f)-\mathrm{E}\left[X_{i}(f)\right]\right\}$. Also,
for i.i.d. random variables $\xi=\left(\xi_{i}\right)_{i=1}^{n}$ independent from $\left(X_{i}\right)_{i=1}^{n}$, we let $\mathbb{G}_{n}^{\xi}(f) \equiv n^{-1 / 2} \sum_{i=1}^{n} \xi_{i}\left\{X_{i}(f)-\mathbb{E}_{n}\left[X_{i}(f)\right]\right\}$. We say a class of functions is VC type with envelope $F$ and constants $\bar{A}$ and $v$ if for each $\epsilon>0$, its covering number satisfies $N\left(\mathcal{F},\|\cdot\|_{Q}, \epsilon\|F\|_{Q}\right) \leq(\bar{A} / \epsilon)^{v}$, see [38] for definitions.

Condition A. (i) There exists a countable subset $\mathcal{G}$ of $\mathcal{F}$ such that for every $f \in \mathcal{F}$ there is a sequence $g_{m} \in \mathcal{G}$ with $g_{m} \rightarrow f$ pointwise and $B\left(g_{m}\right) \rightarrow$ $B(f)$. (ii) The class of functions $\mathcal{F}$ is VC type with measurable envelope $F$ and constants $\bar{A} \geq e$ and $v \geq 1$. (iii) There exists constants $b \geq \sigma>0$ and $q \in[4, \infty)$ such that $\sup _{f \in \mathcal{F}} \mathrm{E}\left[|f|^{k}\right] \leq \sigma^{2} b^{k-2}, k=2,3,4$, and $\|F\|_{P, q} \leq b$.

Conditions A(i)-(iii) correspond to the conditions in Chernozhukov et al. [31]. These assumptions imply the existence of a centered Gaussian process $G_{P}$ indexed by $\mathcal{F}$ with uniformly continuous sample paths with respect to the $\mathcal{L}^{2}(P)$-seminorm $d(f, g)=\left\{\mathrm{E}\left[(f-g)^{2}\right]\right\}^{1 / 2}$ and covariance operator given $\mathrm{E}\left[G_{P}(f) G_{P}(g)\right]=\operatorname{cov}(f(X), g(X))$.

Next we turn to conditions that are specific to the setting we consider.
Condition B. (i) The class of functions $\mathcal{F}$ can be written as $\mathcal{F}=\{f \in$ $\mathcal{F}_{\theta}$, for some $\left.\theta \in \Lambda\right\}$ where $\Lambda \subset \mathbb{R}^{d_{\theta}}$ satisfies $\operatorname{diam}(\Lambda) \leq n$. (ii) There is some $\bar{\chi}>0$ such that for $\gamma_{n} \in(0,1)$, there are constants $C_{\mathcal{F}, \gamma_{n}}$ and $\eta_{\mathcal{F}, \gamma_{n}}$ such that for any $\epsilon>0$ we have

$$
P\left(\sup _{\theta, \tilde{\theta} \in \Lambda,\|\theta-\tilde{\theta}\| \leq \epsilon}\left|\sup _{f \in \mathcal{F}_{\theta}} B(f)+\mathrm{G}(f)-\sup _{\tilde{f} \in \mathcal{F}_{\tilde{\theta}}} B(\tilde{f})+\mathrm{G}(\tilde{f})\right|>C_{\mathcal{F}, \gamma_{n}} \epsilon^{\bar{x}}+\eta_{\mathcal{F}, \gamma_{n}}\right) \leq \gamma_{n},
$$

for $\mathrm{G}=G_{P}, \mathbb{G}_{n}, \mathbb{G}_{n}^{\xi}$, and with $\xi=\left(\xi_{i}\right)_{i=1}^{n}$ are i.i.d. $N(0,1)$.

Condition $B(i)$ postulates the function class is parameterized by two indices. Condition $B(i i)$ is a high level condition that allows us to construct a net for the functionals $\left\{\sup _{f \in \mathcal{F}_{\theta}} B(f)+\mathbb{G}_{n}(f): \theta \in \Lambda\right\}$ and $\left\{\sup _{f \in \mathcal{F}_{\theta}} B(f)+\right.$ $\left.G_{P}(f): \theta \in \Lambda\right\}$. It is implied by typical equicontinuity assumptions imposed on the whole process $\left\{B(f)+\mathbb{G}_{n}(f): \theta \in \Lambda, f \in \mathcal{F}_{\theta}\right\}$ (see van der Vaart and Wellner [53] for general definitions and for moment inequalities models see Andrews and Shi [4, 6], Bugni et al. [21]). However, Condition B(ii) allows for non-Donsker classes as the constant $C_{\mathcal{F}, \gamma_{n}}$ can increase with the sequence of the data generating process. The case $\bar{\chi}=1$ and $\eta_{\mathcal{F}, \gamma_{n}}=0$ covers the important case in which the functions in $\mathcal{F}_{\theta}$ and the operator $B$
are Lipschitz functions of $\theta$ whose constant can increase with the dimension $d_{\theta}$. The case $\bar{\chi}=1$ and $\eta_{\mathcal{F}, \gamma_{n}}=o(1)$ allows for discontinuous functions. In Section 4 below we provide simple conditions that imply Condition B(ii).

Recently new central limit theorems for high-dimensional vectors have been derived in a sequence of papers by Chernozhukov et al. [27, 28, 29, 30, 31]. They have been used to construct Gaussian approximations for the distribution of the maximum of the components as in the case of many moment studied in Chernozhukov et al. [25]. In this work, we build upon these tools and ideas to develop new Gaussian approximation for the MinMax statistic.

In what follows it will be convenient to define

K_{n}=\log N_{B}(\eta)+v\{\log n \vee \log (\bar{A} b / \sigma)\}+\left(d_{\theta} / \bar{\chi}\right) \log \left(n C_{\mathcal{F}, \gamma_{n}} b / \sigma\right) \tag{6.1}
\end{equation*}
$$

which is an entropy measure associated with the class of function $\mathcal{F}$. The following theorem provides a key result for our analysis.

Theorem 8. Suppose that Conditions $A$ and $B$ are satisfied and $K_{n}^{3} \leq n$. Define the random variable $T=\inf _{\theta \in \Lambda} \sup _{f \in \mathcal{F}_{\theta}} B(f)+\mathbb{G}_{n}(f)$. Then, for every $\gamma_{n} \in(0,1)$, there exists a random variable $\widetilde{T}={ }_{d} \inf _{\theta \in \Lambda} \max _{f \in \mathcal{F}_{\theta}} B(f)+$ $G_{P}(f)$ such that

$$
\mathrm{P}\left(|T-\widetilde{T}|>C \delta_{n, \eta, \gamma_{n}}\right) \leq C^{\prime}\left\{\gamma_{n}+n^{-1}\right\},
$$

where $C, C^{\prime}$ are constants that depend only on $q$,

\delta_{n, \eta, \gamma_{n}}=\frac{\left(b \sigma^{2} K_{n}^{2}\right)^{1 / 3}}{\gamma_{n}^{1 / 3} n^{1 / 6}}+\frac{b K_{n}}{\gamma_{n}^{1 / q} n^{1 / 2-1 / q}}+\eta_{\mathcal{F}, \gamma_{n}}+\eta,
$$

and $={ }_{d}$ means equality in distribution.
Theorem 8 above establishes that we can approximate the value of the MinMax statistic with the MinMax of Gaussian processes. A crucial step in the proof of Theorem 8 was the development of a new smooth approximation function for the MinMax operator. Finally, in most applications the parameters $\eta_{\mathcal{F}, \gamma_{n}}$ and $\eta$ are dominated by the other terms in $\delta_{n, \eta, \gamma_{n}}$ (e.g., see Section 4).

Our next result shows that the distribution of the MinMax of the Gaussian process is close to the distribution of the MinMax of our bootstrap approximation.

Theorem 9. Suppose that Conditions $A$ and $B$ are satisfied and $K_{n} \leq n$ and let $S=\inf _{\theta \in \Lambda} \sup _{f \in \mathcal{F}_{\theta}} B(f)+\mathbb{G}_{n}^{\xi}(f)$. Then, for every $\gamma_{n} \in(0,1)$, there exists a random variable $\widetilde{S}={ }_{d \mid\left(X_{i}\right)_{i=1}^{n}} \inf _{\theta \in \Lambda} \sup _{f \in \mathcal{F}_{\theta}} B(f)+G_{P}(f)$ such that

$$
\mathrm{P}\left(|S-\widetilde{S}|>C \bar{\delta}_{n, \eta, \gamma_{n}}\right) \leq C^{\prime}\left\{\gamma_{n}+n^{-1}\right\}
$$

where $C, C^{\prime}$ are universal constants that depend on $q$,

$$
\bar{\delta}_{n, \eta, \gamma_{n}}=\frac{\left(b \sigma K_{n}^{3 / 2}\right)^{1 / 2}}{\gamma_{n}^{1+1 / q} n^{1 / 4}}+\frac{b K_{n}}{\gamma_{n}^{1+1 / q} n^{1 / 2-1 / q}}+\eta_{\mathcal{F}, \gamma_{n}}+\eta
$$

and $={ }_{d \mid\left(X_{i}\right)_{i=1}^{n}}$ means equality in conditional distribution given $\left(X_{i}\right)_{i=1}^{n}$.
The combination of Theorems 8 and 9 provide a constructive way to approximate the distribution of $T$ by simulating $S$ which is associated with the process induced by the multiplier bootstrap procedure.

Remark 9 (Other Bootstrap Procedures). It seems it possible to apply other bootstrap procedures. Of particular interest is the use of the empirical bootstrap which allows to match higher order moments relative to the Gaussian multiplier bootstrap (which can lead to weaker requirements when compared to Theorem 8). Indeed, the main novelty of the proofs in Theorems 8 and 9 is the use of a new approximating function to handle the MinMax structure we are concerned here. Any improvements on coupling results for smooth functions can be incorporated.
6.2. MinMax of High-dimensional Matrices. In this section we collect key results for coupling the MinMax of the components of high-dimensional matrices. They are of independent interest and apply for non-i.i.d. matrices. We first state a coupling result between (arbitrary) random matrices and Gaussian random matrices for the MinMax operator. In what follows let $\mathbb{V}\left(X_{i}\right)=\mathrm{E}\left[\left(X_{i}-\mathrm{E}\left[X_{i}\right]\right)\left(X_{i}-\mathrm{E}\left[X_{i}\right]\right)^{\prime}\right]$.

ThEOREM 10. Let $\left(X_{i}\right)_{i=1}^{n}$ be independent random matrices in $\mathbb{R}^{N \times p}$ (with $N p \geq 2$ ) with finite absolute third moments componentwise, and $\left(Y_{i}\right)_{i=1}^{n}$ be independent random matrices in $\mathbb{R}^{N \times p}$ with $Y_{i} \sim N\left(\mathrm{E}\left[X_{i}\right], \mathbb{V}\left(X_{i}\right)\right)$. Set

$$
Z=\min _{k \in[N]} \max _{j \in[p]} \frac{1}{\sqrt{n}} \sum_{i=1}^{n} X_{i k j} \quad \text { and } \quad \widetilde{Z}=\min _{k \in[N]} \max _{j \in[p]} \frac{1}{\sqrt{n}} \sum_{i=1}^{n} Y_{i k j}
$$

Then for any $\delta>0$ and Borel subset $A$ of $\mathbb{R}$,

$$
\mathrm{P}(Z \in A) \leq \mathrm{P}\left(\widetilde{Z} \in A^{C \delta}\right)+\frac{C \log ^{2}(N p)}{\delta^{3} n^{1 / 2}}\left\{L_{n}+M_{n, X}(\delta)+M_{n, Y}(\delta)\right\}
$$

where $C>0$ is a universal constant, and
$L_{n}=\max _{k \in[N], j \in[p]} \frac{1}{n} \sum_{i=1}^{n} \mathrm{E}\left[\left|\widetilde{X}_{i k j}\right|^{3}\right]$,
$M_{n, X}(\delta)=\frac{1}{n} \sum_{i=1}^{n} \mathrm{E}\left[\max _{k \in[N], j \in[p]}\left|\widetilde{X}_{i k j}\right|^{3} 1\left\{\max _{k \in[N], j \in[p]}\left|\widetilde{X}_{i k j}\right|>\delta \sqrt{n} / \log (N p)\right\}\right]$,
$M_{n, Y}(\delta)=\frac{1}{n} \sum_{i=1}^{n} \mathrm{E}\left[\max _{k \in[N], j \in[p]}\left|\widetilde{Y}_{i k j}\right|^{3} 1\left\{\max _{k \in[N], j \in[p]}\left|\widetilde{Y}_{i k j}\right|>\delta \sqrt{n} / \log (N p)\right\}\right]$,
for $\widetilde{X}_{i}=X_{i}-\mathrm{E}\left[X_{i}\right]$ and $\widetilde{Y}_{i}=Y_{i}-\mathrm{E}\left[Y_{i}\right]$.
The following theorem establishing a coupling result regarding two Gaussian random matrices for the MinMax operator. This result is important to establish the validity of the Gaussian multiplier bootstrap which relies on an estimate of the covariance matrix of the original process.

Theorem 11. Let $X$ and $Y$ be random matrices in $\mathbb{R}^{N \times p}(N p \geq 2)$ with $X \sim N\left(\mu, \Sigma^{X}\right)$ and $Y \sim N\left(\mu, \Sigma^{Y}\right)$. Define $T=\min _{k \in[N]} \max _{j \in[p]} X_{k j}$ and $\widetilde{T}=\min _{k \in[N]} \max _{j \in[p]} Y_{k j}$. Then for any $\delta>0$ and Borel subset $A$ of $\mathbb{R}$,

$$
\mathrm{P}(T \in A) \leq \mathrm{P}\left(\widetilde{T} \in A^{5 \delta}\right)+C \delta^{-2}\left\|\Sigma^{X}-\Sigma^{Y}\right\|_{\infty} \log (N p),
$$

where $\left\|\Sigma^{Y}-\Sigma^{X}\right\|_{\infty}=\max _{(k, j) \in[N]^{2} \times[p]^{2}}\left|\Sigma_{\left(k_{1} j_{1}, k_{2} j_{2}\right)}^{Y}-\Sigma_{\left(k_{1} j_{1}, k_{2} j_{2}\right)}^{X}\right|$ and $C>0$ is a universal constant.

Theorems 10 and 11 parallels the results for non-central random vectors for the max operator obtained in Chernozhukov et al. [31]. Their proofs rely on the use of a novel smooth approximation of the MinMax that is a suitable composition of the logarithm of the sum of the exponentials.

## APPENDIX A: EXAMPLE

Example 3. Consider $d_{\theta}=2, \Theta=[-1,1]^{2}$. Let $p=2$ and the following moment inequalities

\Theta\left(h_{0}\right)=\left\{\theta \in \Theta: \theta_{1}=0\right\} \quad \text { and } \quad \Theta_{I}=\left\{\theta \in \Theta: \theta_{1}+\theta_{2}=0\right\}

It follows that for $\left(Z_{1}, Z_{2}\right) \sim N(0, I)$ we have

In contrast, setting $R_{n}^{*}(0)=\min _{\theta \in \Theta(0)} \max _{j \in[p]} \hat{v}_{\theta, j}$ we have

Therefore, critical values based on the conditional quantiles of $R_{n}^{*}(0)$ given the data fail to control size. For example, for $\alpha=0.1$, it follows $c_{n}(0, \alpha) \approx$ 0.5 and $P\left(T_{n}(0)>c_{n}(0, \alpha)\right) \approx 0.24$, while the $(1-\alpha)$-quantile of $T_{n}(0)$ is $\approx 0.86$.

& \leq{ }_{(3)}-\sup _{\theta \in \Theta(\bar{h}), j \in[p]}\left|\hat{v}_{\theta, j}\right| \\
& \leq{ }_{(4)}-\sup _{\theta \in \Theta(\bar{h}), j \in[p]}\left|\hat{v}_{\theta, j}^{*}\right|+\delta_{4} \\

where (1) holds by $\inf _{k} \max _{m} a_{k m}+b_{k m} \leq \max _{k, m}\left|a_{k m}\right|+\inf _{k} \max _{m} b_{k m}$, (2) by $\sup _{\theta \in \Theta(\bar{h}), j \in[p]}\left|\hat{v}_{\theta, j}\right| \leq \bar{w}_{n} /\left(1-t_{n}^{\sigma}\right)$ holding with probability exceeding $1-2 \gamma_{n}$ and the assumption on $\ell_{\min }$, (3) by the same event, (4) holds by Theorem 8 and 9 with $\delta_{4}=\bar{\delta}_{1}+\bar{\delta}_{2}$ with probability exceeding $1-C\left(\gamma_{n}+n^{-1}\right)$ and (5) holds since $-\sup _{k \in \bar{K}, m \in \bar{M}}\left|a_{k m}\right| \leq \inf _{k \in K} \max _{m \in M} a_{k m}$ for any sets $K \subset \bar{K}$ and $M \subset \bar{M}$. The result then follows in this case.

Case 2: $\ell_{\min }>-2 \bar{w}_{n} /\left(1-t_{n}^{\sigma}\right)$. Since $\Theta_{I}(\bar{h})=\Theta_{I} \cap \Theta(\bar{h}) \neq \emptyset, \ell_{\min } \leq 0$. Moreover, let

Therefore, with probability exceeding $1-2 \gamma_{n}$, by Condition MB we have that for every $\hat{\theta} \in \widehat{\Theta}_{n} \subset \Theta_{n}^{\psi_{n}}$ we can find $\theta_{n}^{*} \in \Theta_{I}(\bar{h})$ such that

and (5) holds with $r_{5}^{\prime}=r_{4}^{\prime}+2 \gamma_{n}$ and $\delta_{5}^{\prime}=\delta_{4}^{\prime}+C \kappa_{n}^{-1} \bar{w}_{n}+C \bar{w}_{n} t_{n}^{\sigma}$.
Using the definitions of $r_{\ell}$ 's and $\delta_{\ell}$ 's, $\ell=1,2,3,4,5$, we have established that

completing the proof of the second statement.
To show the first statement when $\theta_{n} \notin \Theta(\bar{h}) \cap \Theta_{I}$ (i.e. $\max _{j \in[p]} l_{n, j}>0$ ), recall that $\breve{\theta}_{n}=\left(1-\kappa_{n}^{-1}\right) \tilde{\theta}_{n}+\kappa_{n}^{-1} \theta_{n}$. Therefore by (B.13), we have

Condition $\mathrm{MB}(i i i)$ holds by assumption.

Next we verify Condition A, because of the Lipchitz condition, we have that $\mathcal{F}$ has $\varepsilon$-covering number bounded by $p\left(6 C_{1} d_{\theta} / \varepsilon\right)^{d_{\theta}}$ so it is VC type with $\bar{A}=6 C_{1} d_{\theta} p^{1 / d_{\theta}}$ and $v=d_{\theta}$. Moreover, since $m_{j}$ 's are uniformly bounded above and the variances $\sigma_{\theta, j}$ are bounded away from zero, we can take $b \leq C_{1}$ and $\mathrm{E}\left[|f|^{k}\right] \leq \sigma^{2} b^{k-2}$ trivially holds and we can take $q=16$. The set of functions $\mathcal{B}=\left\{B(f)=\sqrt{n} \mathrm{E}\left[m_{j}(W, \theta)\right]: j \in[p], \theta \in \Theta\right\}$ has covering number satisfying $N_{B}(\eta) \leq p\left(6 C_{1} d_{\theta} n / \eta\right)^{d_{\theta}}$. Thus we have $K_{n} \leq C \log p+C^{\prime} d_{\theta} \log n$.

Thus the conditions to apply Theorem 2 hold with

Let $K_{n}=\log N_{B}(\eta)+v(\log n \vee \log (\bar{A} b / \sigma))+\left(d_{\theta} / \bar{\chi}\right) \log \left(n C_{\mathcal{F}, \gamma_{n}} b / \sigma\right)$ and $\widetilde{K}_{n}=v\{\log n \vee \log (\bar{A} b / \sigma)\}$. Note that $\widetilde{K}_{n} \leq K_{n}$ and $\log (N p) \leq C K_{n}$.

For that we will apply Theorem 10 for $T^{\varepsilon}=\min _{\theta \in \hat{\Lambda}} \max _{f \in \widehat{\mathcal{F}}_{\theta}} B(f)+\mathbb{G}_{n}(f)$ and $\widetilde{T}^{\varepsilon}=\min _{\theta \in \hat{\Lambda}} \max _{f \in \widehat{\mathcal{F}}_{\theta}} B(f)+G_{P}(f)$ where $N=|\hat{\Lambda}|=\left(12 n^{\frac{3}{2}} C_{\mathcal{F}, \gamma_{n}} b / \sigma\right)^{\frac{d_{\theta}}{\bar{\chi}}}$ and $p \leq\left(4 \bar{A} n^{1 / 2} b / \sigma\right)^{v}$. This will show that for every Borel subset $A$ of $\mathbb{R}$ we have

and the result follows from Strassen's theorem (see e.g. Lemma 4.1 in Chernozhukov et al. [31]).

Under Condition A, by letting $f_{i}=X_{i}(f)$ and $\widetilde{X}_{i}=f_{i}-\mathrm{E}\left[f_{i}\right]$, we have

M_{n, \tilde{X}}(\delta) & =\frac{1}{n} \sum_{i=1}^{n} \mathrm{E}\left[\max _{\theta \in \widehat{\Lambda}, f \in \widehat{\mathcal{F}}_{\theta}}\left|\widetilde{X}_{i f}\right|^{3} 1\left\{\max _{\theta \in \widehat{\Lambda}, f \in \widehat{\mathcal{F}}_{\theta}}\left|\widetilde{X}_{i f}\right|>\delta \sqrt{n} / \log (N p)\right\}\right] \\
& \leq \frac{1}{n} \sum_{i=1}^{n=1} \mathrm{E}\left[\max _{\theta \in \widehat{\Lambda}, f \in \widehat{\mathcal{F}}_{\theta}}\left|\widetilde{X}_{i f}\right|^{3} \max _{\theta \in \widehat{\Lambda}, f \in \widehat{\mathcal{F}}_{\theta}}\left|\widetilde{X}_{i f}\right|^{q-3} /\{\delta \sqrt{n} / \log (N p)\}^{q-3}\right] \\
& \leq \frac{2^{q-1}}{n} \sum_{i=1}^{n} \mathrm{E}\left[\max _{\theta \in \widehat{\Lambda}, f \in \widehat{\mathcal{F}}_{\theta}}\left|f_{i}\right|^{q}\right] /\{\delta \sqrt{n} / \log (N p)\}^{q-3} \\
& \leq 2^{q-1} b^{q}\{\log (N p) /(\delta \sqrt{n})\}^{q-3} .
\end{aligned}
$$

Next note that we can assume $\delta^{3} \geq C \sigma^{2} b n^{-1 / 2} \log ^{2}(N p)$, or equivalently $\delta \geq C^{\prime} \sigma n^{-1 / 6} \log ^{2 / 3}(N p)$ (otherwise the result is trivial as $r_{1 n}(\delta) \geq 1$ ). Then, for $Y_{i f} \sim N\left(\mathrm{E}\left[f_{i}\right], \operatorname{var}\left(f_{i}\right)\right), \widetilde{Y}_{i f}=Y_{i f}-\mathrm{E}\left[f_{i}\right]$, by Lemma 6.6 in Chernozhukov et al. [31] we have

& \leq 12(\delta \sqrt{n} / \log (N p)+c \sigma \sqrt{\log (N p)})^{3} \exp \left(-\delta \sqrt{n} /\left\{c \sigma \log ^{3 / 2}(N p)\right\}\right) \\
& \leq C\{\delta \sqrt{n} / \log (N p)\}^{3} \exp \left(-\delta \sqrt{n} /\left\{c \sigma \log ^{3 / 2}(N p)\right\}\right) \\
& \leq C n^{-2} \sigma^{2} b,
\end{aligned}
$$

where the second and third inequalities follow from under $C \log (N p) \leq$ $K_{n} \leq n^{1 / 3}$ (and the lower bound on $\delta$ ).

Therefore, by Theorem 10 and Strassen's theorem we have

[31]), since $\sigma\left(X_{i}: i=1, \ldots, n\right)$ is countably generated, it suffices to show that there is an event $E \in \sigma\left(X_{i}: i=1, \ldots, n\right)$ such that $\mathrm{P}(E) \geq 1-\gamma_{n}-n^{-1}$ and on the event $E$,

& \text { (ii) } \sup _{f, g \in \mathcal{F}}\left|\mathbb{G}_{n}(f g)\right| \leq C b \sigma \widetilde{K}_{n}^{1 / 2} / \gamma_{n}^{2 / q}+C b^{2} \widetilde{K}_{n} /\left(\gamma_{n}^{2 / q} n^{1 / 2-2 / q}\right) \\
& \text { (iii) }\|F\|_{P_{n}, 2} \leq n^{1 / 2}\|F\|_{P, 2} \text {, }
\end{aligned}
$$

where $\widetilde{K}_{n}=v\{\log n \vee \log (\bar{A} b / \sigma)\}$. Step 0 in the proof of Theorem 2.2 in Chernozhukov et al. [31] established that $\mathrm{P}(E) \geq 1-\gamma_{n}-n^{-1}$.

Step 1. (Main Step.) We discretize the sets $\Lambda$ and each $\mathcal{F}_{\theta}$ and set $N=|\widehat{\Lambda}|$ and $p=\max _{\theta \in \widehat{\Lambda}}\left|\widehat{\mathcal{F}}_{\theta}\right|$. For $\varepsilon>0$, define $S^{\varepsilon}=\min _{\theta \in \widehat{\Lambda}} \max _{f \in \widehat{\mathcal{F}}_{\theta}} B(f)+\mathbb{G}_{n}^{\xi}(f)$ and $\widetilde{S}^{\varepsilon}=\min _{\theta \in \widehat{\Lambda}} \max _{f \in \widehat{\mathcal{F}}_{\theta}} B(f)+G_{P}(f)$ where the sets $\widehat{\Lambda}$ and $\widehat{\mathcal{F}}_{\theta}$ are such that $\left|S-S^{\varepsilon}\right| \leq \varepsilon$ and $\left|\widetilde{S}-\widetilde{S}^{\varepsilon}\right| \leq \bar{\varepsilon}$ with probability exceeding $1-\rho(\varepsilon)$.

By Step 2 below we can take $\bar{\varepsilon}=\sigma /\left(b n^{1 / 2}\right)+\eta_{\mathcal{F}, \gamma_{n}}+\eta+C \sqrt{\sigma^{2} K_{n} / n}+$ $\left(b \sigma K_{n}^{3 / 2}\right)^{1 / 2} /\left(\gamma_{n}^{1 / q} n^{1 / 4}\right)+C b K_{n} /\left(\gamma_{n}^{1 / q} n^{1 / 2-1 / q}\right)$ and $\rho(\varepsilon)=5 n^{-1}+3 \gamma_{n}$. Then we have

& +\left(b \sigma K_{n}^{3 / 2}\right)^{1 / 2} /\left(\gamma_{n}^{1 / q} n^{1 / 4}\right)+C b K_{n} /\left(\gamma_{n}^{1 / q} n^{1 / 2-1 / q}\right)+C \delta,
\end{aligned}
$$

where the first line holds by the triangle inequality, the second holds by Step 3 with probability exceeding $1-\bar{r}_{1 n}(\delta)$, the third inequality holds by Step 2 as stated before. Then, setting $\delta=\bar{\delta}_{n, \eta, \gamma_{n}}$ the result follows by noting that $\log (N p) \leq C K_{n}$ by (6.1) and $\bar{r}_{1 n}\left(\bar{\delta}_{n, \eta, \gamma_{n}}\right) \leq C \gamma_{n}$.

Step 2. (Controlling Discretization Error). Using the same notation as in the proof of Theorem 8, and defining $\psi^{\xi}(\theta):=\sup _{f \in \mathcal{F}_{\theta}}\left(B(f)+\mathbb{G}_{n}^{\xi}(f)\right)$ and $\hat{\psi}(\theta):=\sup _{f \in \widehat{\mathcal{F}}_{\theta}}\left(B(f)+\mathbb{G}_{n}^{\xi}(f)\right)$ we have

where we used that $\widehat{\Lambda}$ is an $\varepsilon_{\Lambda}$-cover of $\Lambda$.

By Step 2 in the proof of Theorem 2.1 of Chernozhukov et al. [31], and Step 2 in the proof of Theorem 2.2 of Chernozhukov et al. [31], we have

\end{gathered}
$$

provided that the event $E$ as defined in (D.2) occurs.
Using Condition B as in Step 2 in the proof of Theorem 8 we have

\mathrm{P}\left(\sup _{\substack{\theta, \tilde{\theta} \in \Lambda,\|\theta-\tilde{\theta}\| \leq \varepsilon_{\Lambda}}}\left|\sup _{f \in \mathcal{F}_{\theta}}\left(B(f)+G_{P}(f)\right)-\sup _{f \in \mathcal{F}_{\tilde{\theta}}}\left(B(f)+G_{P}(f)\right)\right|>\frac{\sigma}{b n^{1 / 2}}+\eta_{\mathcal{F}, \gamma_{n}}\right) \leq \gamma_{n} .

Step 3. (CLT for Discretized Gaussian Process) Next we will establish that in the event $E$ we have

& +\sigma n^{-1 / 2} \sup _{f \in \mathcal{F}}\left|\mathbb{G}_{n}(f)\right|,
\end{align*}

and conditional on $E$, we have

## APPENDIX E: PROOFS OF SECTION 6.2

Proof of Theorem 10. The proof follows similar steps to the proof of Lemma 5.1 in Chernozhukov et al. [28]. For a Borel set $A \subset \mathbb{R}$, define its $\epsilon$ enlargement as $A^{\epsilon}=\{t \in \mathbb{R}: \operatorname{dist}(t, A) \leq \epsilon\}$. Define $\bar{\mu}_{k j}=\frac{1}{\sqrt{n}} \sum_{i=1}^{n} \mathrm{E}\left[X_{i, k j}\right]$, $\bar{\mu}_{k}=\left(\bar{\mu}_{k j}\right)_{j=1}^{p}$, and for a vector $v \in \mathbb{R}^{d}$ we let

In order to approximate the min max operator we will consider the function $G_{\beta}: \mathbb{R}^{N \times p} \rightarrow \mathbb{R}$ defined as

We choose $\beta$ so that $\delta=\beta^{-1} \log (N p)$. By Lemma 5.1 in Chernozhukov et al. [31], for each Borel set $A \subset \mathbb{R}$ and $\delta>0$, there exists a function $g \in C^{3}$, satisfying $\left\|g^{\prime}\right\|_{\infty} \leq \delta^{-1},\left\|g^{\prime \prime}\right\|_{\infty} \leq \delta^{-2} K,\left\|g^{\prime \prime \prime}\right\|_{\infty} \leq \delta^{-3} K$ for a universal constant $K$, such that $1_{A}(t) \leq g(t) \leq 1_{A^{3 \delta}}(t)$ for all $t \in \mathbb{R}$.

To proceed define the composition $m=g \circ G_{\beta}$. Let

& \leq \mathrm{P}\left(\widetilde{Z} \in A^{5 \delta}\right)+\mathrm{E}[m(\widetilde{X})]-\mathrm{E}[m(\widetilde{Y})]
\end{aligned}

We will proceed to bound $\mathrm{E}[m(\widetilde{X})]-\mathrm{E}[m(\widetilde{Y})]$.

Let $\widetilde{W}$ be a copy of $\widetilde{Y}$ and we can assume that $\widetilde{X}, \widetilde{Y}, \widetilde{W}$ are independent. It suffices to bound $\mathrm{E}\left[\mathcal{I}_{n}\right]$ where for $v \in[0,1]$
$\mathcal{I}_{n}=m\left(\sqrt{v} S_{n}^{\tilde{X}}+\sqrt{1-v} S_{n}^{\tilde{Y}}\right)-m\left(S_{n}^{\widetilde{W}}\right), \quad S_{n}^{Q}=n^{-1 / 2} \sum_{i=1}^{n} Q_{i}, \quad Q=\widetilde{X}, \widetilde{Y}, \widetilde{W}$.
Our case corresponds to $v=1$. For a constant $\bar{A} \geq 6$ (independent of $n$ ), and for any $w \in \mathbb{R}^{N \times p}$ and $t>0$, define

& \leq \frac{1}{\sqrt{n}}\left\{\left|\widetilde{X}_{i, m \ell}\right|+\left|\widetilde{Y}_{i, m \ell}\right|+\left|\widetilde{W}_{i, m \ell}\right|\right\}  \tag{E.6}\\
& \leq \frac{1}{\sqrt{n}} 3 \sqrt{n} /(4 \beta)=(3 / 4) \beta^{-1} .
\end{align*}
$$

Therefore, when $h\left(Z^{(i)}(t), 1\right)=0$ and $\chi_{i}=1$, (E.5) and (E.6) we have

\min _{m \in[N]} \max _{\ell \in[p]}\left(Z_{m \ell}^{(i)}(t)+\tau Z_{i, m \ell}(t)+\bar{\mu}_{m \ell}\right) \notin A^{\bar{A} \delta+\frac{1}{4} \beta^{-1}} \tag{E.7}
\end{equation*}
$$

for all $\tau \in[0,1]$, since $\max _{m \in[N], j \in[p]}\left|Z_{i, m \ell}(t)\right| \leq(3 / 4) \beta^{-1}$. In turn, by definition (E.7) implies $h\left(Z^{(i)}(t), 0\right)=0$.

Moreover, (E.7) and

implies that $G_{\beta}\left(Z^{(i)}(t)+\tau Z_{i}(t)\right) \notin A^{\bar{A} \delta-\delta}$.
Therefore by definition of $g$, which implies $1_{A^{\delta}}(t) \leq g(t) \leq 1_{A^{4 \delta}}(t)$, if $G_{\beta}\left(Z^{(i)}(t)+\tau Z_{i}(t)\right) \notin A^{\bar{A} \delta-\delta}$, it follows that $m\left(Z^{(i)}(t)+\tau Z_{i}(t)\right)=(g \circ$ $\left.G_{\beta}\right)\left(Z^{(i)}(t)+\tau Z_{i}(t)\right)=0$ for $\bar{A} \geq 6$ so that $m_{(k, j)}^{\prime \prime \prime}\left(Z^{(i)}(t)+\tau Z_{i}(t)\right)=0$. Therefore, if $h\left(Z^{(i)}(t), 1\right)=0$ and $\chi_{i}=1$ we have (E.4).

Proof of Theorem 11. Similar to the proof of Theorem 10 we define $m=g \circ G_{\beta}, \widetilde{X}=X-\mu$, and $\widetilde{Y}=Y-\mu$ where we can assume $\widetilde{X}$ and $\widetilde{Y}$ to
be independent. Recall that $\left|G_{\beta}(\widetilde{X})-T\right| \leq \beta^{-1} \log (N p)$ by Lemma 11 and we can take $g \in C^{3}(\mathbb{R})$ such that $1_{A}(t) \leq g(t) \leq 1_{A^{3 \delta}}(t)$. Therefore we have

& \leq \mathrm{P}\left(G_{\beta}(\widetilde{Y}) \in A^{\beta^{-1} \log (N p)+3 \delta}\right)+\mathrm{E}[m(\tilde{X})]-\mathrm{E}[m(\widetilde{Y})] \\
& \leq \mathrm{P}\left(\widetilde{T} \in A^{2 \beta^{-1} \log (N p)+3 \delta}\right)+\mathrm{E}[m(\widetilde{X})]-\mathrm{E}[m(\widetilde{Y})] .
\end{aligned}
$$

We will proceed to bound $\mathrm{E}[m(\widetilde{X})]-\mathrm{E}[m(\widetilde{Y})]$. Defining $Z(t)=\sqrt{t} \widetilde{X}+$ $\sqrt{1-t} \widetilde{Y}$ we have

which follows from Stein's identity (see Lemma 2 in Chernozhukov et al. [30]). Therefore, we have

& \leq\left\|\Sigma^{X}-\Sigma^{Y}\right\|_{\infty}\left\{\left\|g^{\prime \prime}\right\|_{\infty}+4 \beta\left\|g^{\prime}\right\|_{\infty}\right\},
\end{aligned}
$$

where the last step follows by Lemma 12 .
Since $\left\|g^{\prime \prime}\right\|_{\infty} \leq \delta^{-2} K$ and $\left\|g^{\prime}\right\|_{\infty} \leq \delta^{-1}$ for some universal constant $K$, and setting $\beta=\delta^{-1} \log (N p)$ we obtain

& \leq \mathrm{P}\left(\widetilde{T} \in A^{5 \delta}\right)+2 C \delta^{-2}\left\|\Sigma^{X}-\Sigma^{Y}\right\|_{\infty} \log (N p) .
\end{aligned}

where (1) from $\sum_{j_{1}, j_{2} \in[p]}\left|w_{j_{1} j_{2}}^{\bar{\mu}_{1}}\left(X_{k_{1}}\right)\right| \leq 2$, (2) from $\delta_{k_{1} k_{2}}=1\left\{k_{1}=k_{2}\right\}$, (3) from $\sum_{j_{3} \in[p]} \pi_{j_{3}}^{\bar{k}_{k_{3}}}\left(X_{k_{3}}.\right)=1$, and (4) from $\sum_{k_{1}, k_{3} \in[N]}\left|w_{k_{1} k_{3}}\left(-F_{\beta}(X)\right)\right| \leq 2$.

Finally, for the twelfth term, we have

$$
\begin{aligned}
& \sum_{(k, j) \in[N]^{3} \times[p]^{3}} A_{(k, j)}^{12}(X) \\
& \leq\left\|g^{\prime}\right\|_{\infty} \sum_{\left.(k, j) \in[N]^{3} \times[p]\right]^{3}} \pi_{k_{1}}\left(-F_{\beta}(X)\right) \delta_{k_{1} k_{2} k_{3}} \beta^{2}\left|q_{j_{1} j_{2 j} j_{3}}^{\bar{\mu}_{k_{1}}}\left(X_{k_{1}}\right)\right| \\
& ={ }_{(1)} \beta^{2}\left\|g^{\prime}\right\|_{\infty} \sum_{k_{1} \in[N]} \pi_{k_{1}}\left(-F_{\beta}(X)\right) \sum_{j_{1}, j_{2}, j_{3} \in[p]} q_{j_{1} j_{2} j_{3}}\left(X_{k_{1}}\right) \mid \\
& \leq_{(2)} 6 \beta^{2}\left\|g^{\prime}\right\|_{\infty} \sum_{k_{1} \in[N]} \pi_{k_{1}}\left(-F_{\beta}(X)\right) \\
& ={ }_{(3)} 6 \beta^{2}\left\|g^{\prime}\right\|_{\infty},
\end{aligned}
$$

where relation (1) follows from $\delta_{k_{1} k_{2} k_{3}}=1\left\{k_{1}=k_{2}=k_{3}\right\}$, (2) follows from $\sum_{j_{1}, j_{2}, j_{3} \in[p]}\left|q_{j_{1} j_{2} j_{3}}^{\bar{\mu}_{k_{1}}}\left(X_{k_{1}}\right)\right| \leq 6$, and (3) from $\sum_{k_{1} \in[N]} \pi_{k_{1}}\left(-F_{\beta}(X)\right)=1$. Collecting all the twelve terms we have

\sum_{(k, j) \in[N]^{3} \times[p]^{3}}\left|m_{(k, j)}^{\prime \prime \prime}(X)\right| \leq\left\|g^{\prime \prime \prime}\right\|_{\infty}+16 \beta\left\|g^{\prime \prime}\right\|_{\infty}+24 \beta^{2}\left\|g^{\prime}\right\|_{\infty}
$$

Lemma 13. For any $\beta>0, g \in C^{3}(\mathbb{R}), m=g \circ G_{\beta}$, and $(k, j) \in$ $[N]^{3} \times[p]^{3}$, define:

U_{(k, j)}(x)=\sup \left\{\left|m_{(k, j)}^{\prime \prime \prime}(x+y)\right|: y \in \mathbb{R}^{N \times p},\|y\|_{\infty} \leq \beta^{-1}\right\} . \tag{F.1}

Then,

\sum_{(k, j) \in[N]^{3} \times[p]^{3}} U_{(k, j)}(x) \leq e^{12}\left\{\left\|g^{\prime \prime \prime}\right\|_{\infty}+16 \beta\left\|g^{\prime \prime}\right\|_{\infty}+24 \beta^{2}\left\|g^{\prime}\right\|_{\infty}\right\}
$$

Proof. As argued in page 1586 of Chernozhukov et al. [27], $\|y\|_{\infty} \leq \beta^{-1}$ implies $\pi_{k}(x+y) \leq e^{2} \pi_{k}(x)$. Therefore,

\begin{aligned}
\sum_{k \in[N]} \sup _{\|y\|_{\infty} \leq \beta^{-1}} \pi_{k}(x+y) & \leq e^{2} \\
\sum_{k_{1}, k_{2} \in[N]} \sup _{\|y\|_{\infty} \leq \beta^{-1}}\left|w_{k_{1}, k_{2}}(x+y)\right| & \leq 2 e^{4} \\
\sum_{k_{1}, k_{2}, k_{3} \in[N]} \sup _{\|y\|_{\infty} \leq \beta^{-1}}\left|q_{k_{1}, k_{2}, k_{3}}(x+y)\right| & \leq 6 e^{6}
\end{aligned}
$$

In turn, we have that

$$
\sum_{(k, j) \in[N]^{3} \times[p]^{3}} U_{(k, j)}(x) \leq e^{12}\left\{\left\|g^{\prime \prime \prime}\right\|_{\infty}+16 \beta\left\|g^{\prime \prime}\right\|_{\infty}+24 \beta^{2}\left\|g^{\prime}\right\|_{\infty}\right\},
$$

where the factor $e^{12}$ accounts for the potential product of six factors of $e^{2}$, i.e., one such factor for each index of the sum.
